**ORDER DECLARING ELECTION OF UNOPPOSED CANDIDATES
AND CANCELING NOVEMBER 5, 2024 DIRECTOR ELECTION**

Recitals

The Board of Directors (the “Board”) of Cottonwood Creek Municipal Utility District No. 1 (the “District”) has called a director election for November 5, 2024 (the “Election”).

The deadline to submit an application for a place on the ballot for the Election was August 19, 2024. The deadline to file an application for write-in candidacy for the Election was August 23, 2024.

The Secretary of the Board is the authority responsible for having the official ballots prepared for the Election and, on September 3, 2024, submitted to the Board the “Certification of Unopposed Status of Candidates for the November 5, 2024 Director Election”, attached as **Exhibit “A”**.

Under Section 2.053 of the Texas Election Code, if the Board receives a certification of unopposed status of candidates, it shall declare each unopposed candidate elected to office.

Therefore, the Board orders that:

1. The “Certification of Unopposed Status of Candidates for the November 5, 2024 Director Election” submitted on September 3, 2024 is accepted.
2. Keith E. Young is elected to office in Place 1, Nicholas Whittaker is elected to office in Place 2, and Gerald Aalbers is elected to office in Place 4 as Directors for the District; their terms will begin on November 5, 2024; and they will begin their duties as Director after executing a Statement of Elected Officer and taking the Oath of Office.
3. The Election is canceled.
4. This Order will constitute a certificate of election, and the Secretary of the Board is directed to issue and deliver a copy to each candidate as required by Section 67.016 of the Texas Election Code and to post a copy of this Order at the polling place on the Election day.

This Order may be executed in one or more counterparts, each of which will be deemed an original and all of which together will constitute one and the same instrument. A digital signature, a facsimile or other electronic copy of an original signature, and/or a counterpart transmitted electronically (*e.g.*, by fax, email, text, or similar means), will be deemed to be, and will have the same force and effect as, an original signature for all purposes.



**CERTIFICATION OF UNOPPOSED STATUS OF CANDIDATES
FOR THE NOVEMBER 5, 2024 DIRECTOR ELECTION**

The undersigned, the Secretary of the Board of Directors of Cottonwood Creek Municipal Utility District No. 1 (the "District"), is the authority responsible for having the official ballots prepared for the November 5, 2024, Director election for the District and certifies that:

1. One Director for Place 1, one Director for Place 2, and one Director for Place 4 of the District are to be elected at the November 5, 2024, Director election.
2. The deadline for filing an application for a place on the ballot was August 19, 2024, and only one candidate for Place 1, one candidate for Place 2, and one candidate for Place 4 filed for places on the ballot.
3. The deadline for filing an application for write-in candidacy was August 23, 2024, and no write-in candidates filed.

5. No proposition is scheduled to appear on the ballot.

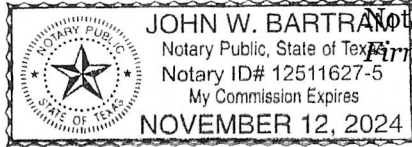
