CITY OF CREEDMOOR ORDINANCE NO. 240919-A

AN ORDINANCE OF THE CITY OF CREEDMOOR, TEXAS, DECLARING UNOPPOSED CANDIDATES FOR THREE POSITIONS ON THE BOARD OF ALDERMAN; DECLARING THE UNOPPOSED CANDIDATES ELECTED TO OFFICE; CANCELLING THE NOVEMBER 5, 2024, GENERAL ELECTION; REQUIRING THE MUNICIPAL CLERK TO POST A COPY OF THIS ORDINANCE AT EACH POLLING PLACE; AUTHORIZING CERTIFICATES OF ELECTION TO BE ISSUED; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING A SAVINGS CLAUSE; PROVIDING AN EFFECTIVE DATE AND OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, on September 19, 2024, the Creedmoor Board of Alderman called for a General Election to be held in the City of Creedmoor on November 5, 2024, for the purpose of electing three aldermen to the Creedmoor Board of Alderman; and

WHEREAS, on September 19, 2024, John Gray, filed an application for a place on the City of Creedmoor ballot for Board of Alderman; and

WHEREAS, on September 19, 2024, Jeff Jakobeit, filed an application for a place on the City of Creedmoor ballot for Board of Alderman; and

WHEREAS, on September 19, 2024, Jesse Solis, filed an application for a place on the City of Creedmoor ballot for Board of Alderman; and

WHEREAS, as of August 23, 2024, at 5:00 p.m. no individual had filed a declaration of write-in candidacy for a place on the ballot for Board of Alderman; and

WHEREAS, on August 28, 2024, the Municipal Clerk certified that the three candidates for Board of Alderman were unopposed, and a copy of the certification is attached as **Exhibit A**; and

WHEREAS, under these circumstances, Subchapter C, Section 2 of the Texas Election Code authorizes the Board of Alderman to declare the candidates elected to office and cancel that election.

BE IT HEREBY ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF CREEDMOOR, TEXAS:

Section I.

That the Creedmoor Board of Alderman hereby declares the following candidates elected to the position of Board of Alderman Member of the Board of Alderman of the City of Creedmoor, Texas: John Gray, Jeff Jakobeit, Jesse Solis.

Section II.

That the General Election for November 5, 2024, is cancelled.

Section III.

That the Municipal Clerk shall post a copy of this ordinance on Election Day, November 5, 2024, at the polling places used or that would have been used in the election.

Section IV.

That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section V.

That the terms and provisions of this ordinance shall be deemed to be severable and that if any section, subsection, sentence, clause, or phrase of this ordinance shall be declared to be invalid or unconstitutional, the same shall not affect the validity of any other section, subsection, sentence, clause, or phrase of this ordinance and the remainder of such ordinance shall continue in full force and effect the same as if such invalid or unconstitutional provision had never been a part hereof.

Section VI.

That it is hereby officially found and determined that the meeting at which this ordinance is passed is open to the public and that public notice of the time, place, and purpose of said meeting was given as required by law.

THIS ORDINANCE HAS BEEN PASSED AND APPROVED BY A MAJORITY VOTE OF THE BOARD OF ALDERMAN OF THE CITY OF CREEDMOOR, TEXAS, ON THE 19th DAY OF SEPTEMBER, 2024 TO BE EFFECTIVE UPON ANY PUBLICATION REQUIRED BY LAW.
