

RESOLUTION NO. 2279-26-08-11-1441

RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS  
ORDERING A MUNICIPAL GENERAL ELECTION

WHEREAS, the City Council of the City of Pflugerville wishes to order a November 3, 2026, general election for the purpose of electing Council Place 2, Place 4, and Place 6; and

WHEREAS, the City of Pflugerville enters into agreements with Travis County and Williamson County respectively to conduct the City's elections, pursuant to *Chapter 31, Tex. Elec. Code, and Chapter 791, Tex. Gov't Code* and such agreements provide for political subdivisions that hold elections on the same day in all or part of the same territory to hold joint elections as authorized in *Chapter 271, Tex. Elec. Code*; and

WHEREAS, the Travis County Clerk is designated as the Travis County Election Officer and the City of Pflugerville has appointed the Travis County Election Officer to serve as the City of Pflugerville's Election Officer and Early Voting Clerk to conduct the City's elections through its election agreement with Travis County; and

WHEREAS, the Williamson County Elections Administrator is designated as the Williamson County Election Officer and the City of Pflugerville has appointed the Williamson County Election Officer to serve as the City of Pflugerville's Election Officer and Early Voting Clerk to conduct the City's elections through its election agreement with Williamson County; NOW THEREFORE,

BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS, THAT:

1. The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.
2. A general election shall be held for the City of Pflugerville, Texas (the "City") on the 3<sup>rd</sup> day of November, 2026, between the hours of 7:00 a.m. and 7:00 p.m. for the purpose of electing Council Place 2, Place 4, and Place 6; and
3. Notice of the election shall be given and the election shall be held in compliance with the provisions of the *Tex. Elec. Code* in all respects. The ballots for the election shall comply with the *Tex. Elec. Code* and be in the form provided by the City to the Travis County and Williamson County Election Officers for use on the voting devices and ballots used by the Travis County and the Williamson County Election Officers.
4. The Travis County Election Officer and their employees and appointees, the Williamson County Election Officer and their employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election shall hold and conduct the election in the manner provided by agreement with the City and

the law governing the holding of general elections by home rule cities of the State of Texas; and the official ballots, together with such other election materials as are required by the *Tex. Elec. Code*, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.

5. The election precincts for the election shall be the election precincts established by Travis County and Williamson County respectively, provided that each shall contain and include geographic area that is within the City. Polling places for the election shall be at the locations established by the City in consultation with Travis County and Williamson County. The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Travis County will be provided by precinct and the Travis County Election Officer shall tabulate and provide the election returns for the election. The returns for precincts in Williamson County will be provided by precinct and the Williamson County Election Officer shall tabulate and provide the election returns for the election.
6. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Travis County and Williamson County and their appointees in compliance with the requirements of state law, and such judges and clerks so selected by Travis County and Williamson County and their appointees are hereby designated and appointed by the City Council as the election officers, judges and clerks, respectively, for the holding of said general election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law.
7. Early voting, both by personal appearance and by mail, will be conducted by the Travis County Election Officer, and the Williamson County Election Officer who are designated and appointed as Early Voting Clerk for voters in their respective counties, in accordance with the *Texas Election Code*. Early voting by personal appearance shall be conducted at places and locations authorized by state law, the City, and the Travis and Williamson County Election Officers. Early voting shall commence on October 19, 2026 and continue through October 30, 2026.
8. A list of Election Day and early voting locations, dates and times are attached in Exhibits A and B and are subject to change.
9. Applications for voting by mail for all residents of the City shall be received, not postmarked, by October 23, 2026.

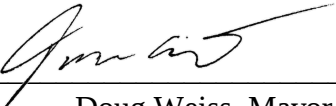

10. All qualified resident electors of the City shall be entitled to vote in the election.
11. The City Secretary is authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Tex. Elec. Code* and *City Charter*; provided that, pursuant to the Election Agreements between Travis County and the City, and Williamson County and the City; the County Election Officers shall have the duty and be responsible for organizing and conducting the election in compliance with the *Tex. Elec. Code*; and for providing all services specified to be provided in the Election Agreements. The County Election Officers shall give the notices required by the *Tex. Elec. Code* to be given for the election not required to be given by the City under the Election Agreement.
12. The City Manager is authorized to execute contracts for election services with Travis County and Williamson County and joint election agreements as appropriate for conducting the November 3, 2026 election.

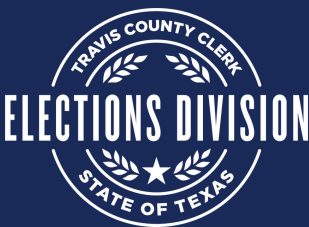

**ORDINANCE NO. 1716-26-08-11**

**ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS  
ORDERING A SPECIAL ELECTION ON PROPOSED  
AMENDMENTS TO THE HOME RULE CHARTER**

**WHEREAS**, the Home Rule Charter for the City of Pflugerville, Texas, requires that the City Council appoint a Charter Review Commission every five years composed of not fewer than 13 nor more than 20 members to inquire into the operations of city government, review the charter, propose recommendations for compliance with charter provisions, propose charter amendments and make a written report of its finding; and

**WHEREAS**, on November 12, 2025, the City Council of the City of Pflugerville created a twenty-member Charter Review Commission for the purpose of reviewing the City of Pflugerville Charter and appointed 15 members. On November 25, 2025 City Council appointed two additional members. Pursuant to Section 11.11 of the City home rule charter the Commission was charged with (1) inquiring into the operations of city government and reviewing the city charter to determine whether it required revision; (2) proposing any recommendations it deems desirable to ensure compliance with charter provisions by city departments; (3) proposing any charter amendments it deems desirable to improve the effective application of the charter to current conditions; and (4) making a written report of its findings and recommendations to the city council; and

**WHEREAS**, the Charter Review Commission presented a report, together with proposed changes to the City's Charter to the City Council on July 14, 2026; and

**WHEREAS**, in accordance with Section 9.004 of the Texas Local Government Code and Section 11.11 of the Home Rule Charter for the City of Pflugerville, the City Council is required to order an election regarding the proposed amendments to the Charter; and

**WHEREAS**, in accordance with Texas Local Government Code, Chapter 9, the City Council finds it appropriate to submit additional proposed charter amendments on its own motion to the qualified voters of the City of Pflugerville for their consideration.

**NOW THEREFORE,**

**BE IT ORDAINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS, THAT:**

1. The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.
2. A special election shall be held for the City of Pflugerville, Texas (the "City") on the 3rd day of November 2026, between the hours of 7:00 a.m. and 7:00 p.m. to consider amendments to the City of Pflugerville's Home Rule Charter.

3. Notice of the election shall be given and the election shall be held in compliance with the provisions of the Texas Election Code in all respects. The ballots for the election shall comply with the Texas Election Code and be in the form provided by the City to the Travis County and Williamson County Election Officers for use on the voting devices and ballots used by the Travis County and the Williamson County Election Officers.
4. The Travis County Election Officer and his/her employees and appointees, the Williamson County Election Officer and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election shall hold and conduct the election in the manner provided by agreement with the City and the law governing the holding of special elections by home rule cities of the State of Texas; and the official ballots, together with such other election materials as are required by the Texas Election Code, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.
5. The election precincts for the election shall be the election precincts established by Travis County and Williamson County respectively, provided that each shall contain and include geographic area that is within the City. Polling places for the election shall be at the locations established by the City in consultation with Travis County and Williamson County. The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Travis County will be provided by precinct and the Travis County Election Officer shall tabulate and provide the election returns for the election. The returns for precincts in Williamson County will be provided by precinct and the Williamson County Election Officer shall tabulate and provide the election returns for the election.
6. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Travis County and Williamson County and their appointees in compliance with the requirements of state law, and such judges and clerks so selected by Travis County and Williamson County and their appointees are hereby designated and appointed by the City Council as the election officers, judges and clerks, respectively, for the holding of said special election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law.
7. Early voting, both by personal appearance and by mail, will be conducted by the Travis County Election Officer, and the Williamson County Election Officer who are designated and appointed as Early Voting Clerk for voters in their respective counties, in accordance with the Texas Election Code. Early voting by personal appearance shall be conducted at places and locations authorized by state law, the City, and the Travis and Williamson County Election Officers. Early voting shall commence on October 19, 2026 and continue through October 30, 2026. A list of Election Day and early voting locations are attached as Exhibits B and C and are subject to change.

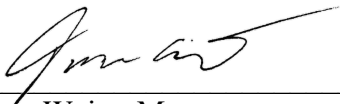

9. Applications for early voting ballots by mail must be received by the close of business on October 23, 2026. Marked early voting ballots by mail must be received no later than 7:00 p.m. on November 3, 2026.
10. All qualified resident electors of the City shall be entitled to vote in the election.
11. At the election, as listed on Exhibit “C,” the Measures shall be submitted to the voters in the form of their accompanying Propositions. Measure “I” being a City Council submitted measure and the remaining measures being Commission submitted measures.
12. The City Secretary is authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the Texas Local Government Code, Texas Election Code and City Charter; provided that, pursuant to the Election Agreements between Travis County and the City, and Williamson County and the City; the County Election Officers shall have the duty and be responsible for organizing and conducting the election in compliance with the Texas Election Code; and for providing all services specified to be provided in the Election Agreements. The County Election Officers shall give the notices required by the *Tex. Elec. Code* to be given for the election not required to be given by the City under the Election Agreement.

~~Except as specified below, a proposed ordinance shall be read at two council meetings with at least seventy-two hours elapsing between readings. A proposed ordinance may be amended on first reading; however, if an amendment is made at second reading, final adoption shall be postponed until a subsequent meeting. An ordinance amended prior to adoption need not be read again unless the City Council determines, in its discretion, that an amendment substantively changes the subject matter or scope of the ordinance and votes to require an additional reading. An emergency ordinance shall be adopted in accordance with section 3.16 of this charter; a budget ordinance shall be adopted in accordance with section 9.03 of this charter; an appropriations ordinance shall be adopted in accordance with section 9.04 of this charter; an ordinance pertaining to borrowing shall be adopted in accordance with section 9.05 of this charter; and a tax ordinance shall be adopted in accordance with section 9.08 of this charter.~~

(d) Effective date: Every ordinance shall be effective upon adoption, or at any later time specified in the ordinance; however, no ordinance imposing a penalty, fine, or forfeiture shall become effective until the caption of the ordinance, which shall summarize the purpose of the ordinance and the penalty for violating the ordinance has been published one time on the city's official website or other electronic media that is readily accessible to the public. ~~An ordinance passed on first reading by at least three affirmative votes may become effective after first reading provided the motion so specifies, but the ordinance shall be posted and adopted at a subsequent meeting as required by section 3.15(b).~~

Any member of city council may place an item on the agenda for a subsequent regular council meeting with the consent of a second member of the city council, such item to be placed on an agenda within 60 days of its submission.

### § 3.10. City Council Meetings.

The city council shall meet at least once each month and may hold as many additional meetings as it deems necessary to transact the business of the city. Days and times of regular meetings shall be set by resolution. All meetings shall be posted and conducted in accordance with the requirements of the Texas Open Meetings Act, Chapter 551, Government Code.-The city council shall meet with each Council-created board or commission on an as needed basis. The Mayor shall, with the assistance and input of the City Manager, set and approve the agendas for City Council meetings, which shall include any item submitted pursuant to section 3.05.

(e) Insufficient petition, amendment: If the petition is certified insufficient because it lacks the required number of valid signatures, it may be amended one time only. The petitioners' committee shall file notice that it intends to amend the petition with the city secretary within two working days after receipt of the certificate. A supplementary petition with additional signatures and in a form that complies with sections 7.03(b) and (c) must be filed within ~~two~~ four weeks after receipt of the certificate.

### § 9.03. Annual Budget.

(a) ~~Content-Development:~~ The budget shall provide a complete financial plan of all city funds and activities and, except as required by law or this charter, shall be in a form that the manager deems desirable or that the council may require. The City Manager shall prepare and present the budget according to budget award guidelines currently established by the Government Finance Officers Association, or its successor organization. A budget message explaining the budget both in fiscal terms and in terms of city programs shall be submitted with the budget. The budget message shall (1) outline the proposed financial policies of the city for the coming fiscal year, (2) describe the important features of the budget, (3) indicate any major changes from the current year in financial policies, expenditures, and revenues, with reasons for such changes, (4) summarize the city's debt position, and (5) include other material as the manager deems necessary or desirable.

(b) Content: The budget shall begin with a clear general summary of its contents and shall show in detail all estimated income, based on the proposed property tax levy and all proposed expenditures, including debt service, for the coming fiscal year. The proposed budget expenditures shall not exceed the total of estimated income and any fund balances available from prior years. For every budget adopted after the 1997-1998 fiscal year budget, except in the event of an emergency under Section 9.04(b), the adopted budget must include an unencumbered general fund balance that is at least sufficient to cover three months of the city's budgeted general fund operation and maintenance expenses. This fund balance may be used for emergency appropriations in accordance with Section 9.04(b). The budget shall provide a complete financial plan of all City funds and activities and shall be arranged to show comparative figures for the current fiscal year's adopted budget, year-to-date actual and estimated income and expenditures and estimated year-end results, the preceding fiscal year's adopted budget and actual income and expenditures, and the estimate of income and expenditures for the upcoming budgeted year. The budget shall be presented in a format that allows a meaningful comparison of trends in revenues, expenditures, staffing levels, and long-term obligations. It shall include in separate sections:

- ~~1. An itemized, estimate of the expense of conducting each department, division, and office.~~
- ~~2. Reasons for proposed increases or decreases in specific expenditures, compared with the current fiscal year.~~

- ~~3. A separate schedule for each department, indicating tasks to be accomplished by the department during the year, and additional desirable tasks to be accomplished if possible.~~
- ~~4. A statement of the total probable income of the city from taxes for the period covered by the estimate.~~
- ~~5. Tax levies, rates, and collections for the preceding five years.~~
- ~~6. All anticipated revenue from itemized sources other than the tax levy.~~
- ~~7. The amount required for interest on the city's debts, for the sinking fund, and for maturing serial bonds.~~
- ~~8. The total principal amount of outstanding city debts, with a consolidated schedule of debt service requirements.~~
- ~~9. Anticipated net surplus or deficit for the coming fiscal year of each utility owned or operated by the city and the proposed method of its disposition. Subsidiary budgets for each utility, with detailed income and expenditure information shall be attached as appendices to the budget.~~
- ~~10. A capital program, which may be revised and extended each year to indicate capital improvements pending or in process of construction or acquisition, that includes the following items: (a) a summary of proposed programs; (b) a list of all capital improvements proposed to be undertaken during the next five fiscal years, with appropriate supporting information regarding the necessity for the improvements, including the five year plan related to that particular type of capital improvement; (c) cost estimates, methods of financing, and recommended time schedules for each improvement; and (d) the estimated annual cost of operating and maintaining the facilities to be constructed or acquired.~~
- ~~11. Other information required by the council.~~

(c) Financial Forecast: The budget shall include a five-year financial forecast, to include projected revenues, expenditures, debt service obligations, capital expenditures, and anticipated impacts on the property tax rate and utility rates.

#### **§ 9.08. Capital Project Public Reporting System.**

The City shall maintain a publicly accessible online reporting system for major capital projects. Upon the completion of a capital project, the City shall maintain a final close-out report. The City shall retain such reports for not less than five (5) years after project completion.

A non-voting ETJ advisory participant shall not vote, count toward quorum, serve as chair or vice-chair, participate in executive session unless authorized by law, or alter the residency requirements for voting members.

The ordinance authorizing ETJ advisory participation shall identify the eligible boards or commissions and may establish appointment procedures, eligibility requirements, terms, duties, limits, and participation procedures.

ETJ advisory participation shall not apply to a board or commission exercising quasi-judicial, appellate, adjudicatory, enforcement, or other legally restricted functions unless expressly authorized by state law.

#### § 1.02. Form of Government.

The municipal government provided by this charter shall be the city council-manager form of government, consisting of a mayor and council members, elected by the people and responsible to the people, and a ~~€~~City ~~m~~Manager, appointed by and responsible to the council for proper administration of the ~~€~~City....

*[Illustrative. Conforming capitalization changes (e.g., "city" to "City," "manager" to "Manager") shall be applied throughout the Charter consistent with standard drafting conventions.]*

#### § 1.05. ~~Detachment or Contraction of Boundaries~~Disannexation.

The city council by ordinance may ~~detach-disannex~~ any territory not suitable or necessary for city purposes with or without the consent of the inhabitants or owners of the area to be ~~detached-disannexed~~. In ~~detaching~~ disannexing any area, the city council shall hold a public hearing on the ~~proposed detachment proposal~~. Notice of the meeting where the public hearing is to be held shall comply with the notice provision of the Texas Open Meetings Act, Texas Government Code Chapter 551, as amended or revised, as prescribed by Local Government Code § 43.052. The ordinance ~~detaching~~ disannexing an area shall specify accurately, by metes and bounds, the affected area.

#### § 3.10. City Council Meetings.

The city council shall meet at least once each month and may hold as many additional meetings as it deems necessary to transact the business of the city. Days and times of regular meetings shall be set by resolution. ~~All meetings shall be posted and conducted in accordance with the requirements of the Texas Open Meetings Act, Chapter 551, Government Code.~~ The city council shall meet with each board or commission on an as needed basis. The Mayor shall, with the assistance and input of the City Manager, set and approve the agendas for City Council meetings.

### **§ 3.14. Action Requiring an Ordinance.**

In addition to other acts required by law or by specific provision of this charter to be done by ordinance, the city council shall adopt ordinances in order to:

1. Authorize the borrowing of money.
2. Convey or lease or authorize the conveyance or lease of any city land.

~~Acts other than those specifically enumerated above may be done either by ordinance or resolution.~~

### **§ 4.01. City Manager.**

9. Serve as officer for public records in accordance with ~~the Texas Open Records Act, Chapter 552, Government Code state law,~~ and the custodian of records under the Local Government Records Act, ~~Subtitle C, Title 6, Local Government Code.~~

### **§ 4.04. City Secretary.**

4. Serve as an agent of the officer of public records in accordance with the requirements of ~~the Texas Open Records Act, Chapter 552, Government Code state law,~~ and the records management officer under the Local Government Records Act, ~~Subtitle C, Title 6, Local Government Code.~~

### **§ 7.03. Petitions.**

(b) Form and content: All papers of a petition shall be of uniform size and style and shall be assembled as one instrument for filing. Each person signing the petition shall personally sign their own name in ink ~~or indelible pencil~~ in accordance with state law, and the petition shall also include each signer's name, voter's registration number or date of birth, residence address and the date of signing. Petitions shall contain or have attached to them throughout their circulation the full text of the ordinance proposed or sought to be reconsidered, or the question proposed to be submitted at a nonbinding referendum election.

### **~~§ 8.07~~11.15. Texas Open Meetings Act.**

~~The City of Pflugerville Council and its Boards and Commissions~~ shall conduct all its meetings in accordance with the Texas Open Meetings Act, Chapter 551, Government Code.

### **§ 11.01. Public Records.**

All records of every office, department, or agency of the city shall be open to inspection by the public, except as may be withheld from public disclosure under the Texas ~~Open Records Act, Chapter 552, Government Code~~ Public Information Act, Chapter 552, Government Code. During regular office hours, any person shall have the right to examine and make copies of any public records of the city in accordance with reasonable rules and regulations prescribed by the city council.

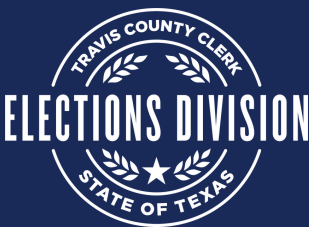
