ORDER CALLING DIRECTORS ELECTION

BE IT ORDERED BY THE BOARD OF DIRECTORS OF CYPRESS RANCH WATER CONTROL AND IMPROVEMENT DISTRICT NO. 1 THAT:

Section 1: An election shall be held for the District on November 3, 2026, between the hours of 7:00 a.m. and 7:00 p.m., at the places listed on Exhibit "A", which will be attached to this Order, being the polling places established by Travis County to serve the county's regular election precinct within the District, as required by Section 42.0621 of the Texas Election Code. The Travis County Clerk is conducting the election pursuant to an Election Agreement between the District and Travis County as authorized under Section 31.092 of the Texas Election Code. The election shall be held as a joint election pursuant to Chapter 271 of the Texas Election Code and a joint election agreement to be entered into between the District and the other participating entities located in Travis County which are holding an election on November 3, 2026. Travis County's election equipment shall be used in the election. At the election, there shall be submitted the question of the election of three (3) directors, each of whom shall serve a four-year term. The election judges and clerks shall be appointed in accordance with the Election Agreement and the Texas Election Code, as amended.

Section 2: Any person interested in applying to be a candidate for the office of director may obtain an application for a place on the ballot from the District's General Counsel, The Law Office of J.R. Cochran, 102 N. Railroad Avenue, Pflugerville, Texas 78660, Telephone No. 512-596-7614. The deadline for candidates to file applications for a place on the ballot is 5:00 p.m. on August 17, 2026. The deadline to file a declaration of write-in candidacy is 5:00 p.m. on August 21, 2026. The address for filing applications for a place on the ballot and declarations of write-in candidacy is The Law Office of J.R. Cochran, 102 N. Railroad Avenue, Pflugerville, Texas 78660.

Section 3: Voting shall be by the use of electronic or paper ballots prepared in both English and Spanish and which shall conform to the requirements of the Texas Election Code. The ballots used in the election shall have the names of the candidates for the office of director and three (3) blank spaces for write-in votes. The voter may vote for none (0), one (1), two (2), or three (3) persons for director by placing an "X" in the square beside the person's name or by writing the name or names of a person or persons in the blank spaces provided.

Section 4. Oral assistance in Spanish shall be made available to all persons requiring such assistance. Any person requiring oral assistance in Spanish should contact the presiding judge or early voting clerk.

Section 5. The boundaries of the District are hereby established as and shall constitute one election precinct for the election. The following are hereby appointed officers of said election:

Travis County Clerk	Election Officer
Travis County Clerk	Early Voting Clerk

The early voting ballot board presiding judge and alternate presiding judge shall be appointed in accordance with the Election Agreement and the Texas Election Code.

Early voting in the election by personal appearance shall begin on October 19, 2026 and shall continue through October 30, 2026. Early voting in the election by personal appearance shall be conducted at the times, dates, and polling places used for the Travis County Joint General and Special Election which will be attached hereto as Exhibit B to this Order. Applications for ballots by mail must be received no later than the close of business on October 23, 2026. The early voting clerk's mailing address to which applications for ballots by mail may be sent is: Elections Division, Travis County Clerk, P. O. Box 149325, Austin, TX 78714-9325.

Section 6: Pursuant to Sections 2.051 through 2.053 of the Texas Election Code, in the event the Secretary of the Board certifies that a candidate is unopposed for election to the office of director, the Board may declare such unopposed candidate elected to the office without an election. The election for that position will not be held.

Section 7: The Secretary of the Board is hereby directed to cause notice of this election to be posted, in English and in Spanish, not later than the 21st day before election day, on the bulletin board used for posting notices of the meetings of the Board of Directors and at a public place in each election precinct in the District. The notice shall remain posted continuously through election day.

Section 8: The election shall be held and conducted and returns made to this Board of Directors in accordance with federal law, the Texas Election Code, as modified by Chapters 49 and 51, Texas Water Code, and the Election Agreement. All qualified resident electors of the District shall be entitled to vote in the election.

Section 9: The President and Secretary are authorized and directed to take any action necessary to carry out the provisions of this order.
