A debt obligation election order required under section 3.009 shall be posted: (1) On election day and during early voting by personal appearance, in a prominent location at each polling place. Additionally, under Section 2.023 a copy of the order or ordinance declaring each unopposed candidate elected to the office shall be posted on election day at each polling place used or that would have been used in the


All voting equipment must be set up and running during voting hours.


- Opening of polls (7AM)
- To polls closing (7PM or when last voter in line at 7PM votes)

DO NOT shutdown BMD's or ePollbooks during voting hours.

- ePollbooks are being updated at regular intervals
- ePollbooks that are shut down during voting hours will not receive updates as needed.

Texas Election Code requires all equipment to remain up and running during voting hours.










Poll Watchers

Poll Watchers:

All poll watchers must present a filled out and signed Certificate of Appointment and a Certificate of Completion form when they arrive at the polling site.

Om Distance Restricted Activities

May not occur within 100 feet of an outside polling place entrance door.


Exceptions: Voters may have written notes but cannot leave them in the polling place.

Electronic Devices

Wireless device use is **prohibited within** 100 feet of voting stations.

Post the provided Prohibition of Certain Devices postings, provided in your Forms Box.

Exceptions: Election officials conducting election business and voters with disabilities using a device to vote.
