A DAY IN THE LIFE of a Curbside Clerk





THE IMPORTANCE OF CURBSIDE CLERKS

Back when I was a wee little girl, my elementary school was a polling site. I remember walking into the cafeteria and seeing booths with curtains that hung to waist level. There were adults waiting in line to go into these booths, pull the curtain, and I could tell by their back of their legs that they were doing something. David Copperfield was huge at the time so I thought they were magicians. I asked Mrs. Walker, my first-grade teacher, "Are they performing magic?"

Mrs. Walker answered, "Yes, they are performing magic. It's called democracy."

Mrs. Walker went on to explain what voting is, why we vote, and why it's important to vote in every single election. My seven-year-old brain was blown away by democracy and I couldn't wait to participate.

Fast forward about thirty years. I was walking through a parking lot on Halloween and broke my ankle. I slipped on some gravel, stepped into a pothole, and that was it. I was just devastated. Not so much about the ankle (it's totally fine now) but at that time, I still haven't voted in the current election. I was putting it off until after the weekend to go early vote and now I was heading to the ER. The doctor informed me I was on bed rest until after the surgery and the surgery was scheduled for the end of the last day of Early Voting. The deadline to request a ballot by mail had passed, so I was worried about not being able to perform the magic of democracy in that election. If only there was another way I could vote?

This is exactly what I think about every time I ask one of you to be a Curbside Clerk. It is amazing that we now have a way for a voter that is unable to physically come into the polling location to participate in the magic of democracy.

Curbside voting is such a vital and necessary part of the voting process. It's for those voters that fall in that tender middle. They missed the deadline to request a ballot by mail but are unable to enter a polling location for various reasons. It could be something like me with my very well broken ankle or it could be like my neighbor that is immunocompromised due to her chemo treatments. In fact, my neighbor wanted me to send her thanks to the Curbside Clerks at Millennium Youth Complex because that was how she was able to vote in the November 2022 General Election.

We need our Curbside Clerks, so if you are willing and capable to step into this role, please volunteer next time we call to assign you a polling location. It is a huge help and a vital service to our community. If you know of anyone that is capable of being a Curbside Clerk and is thinking about working for Elections, encourage them to call us. We thank you in advance!

CURBSIDE CLERK DUTIES



Curbside Clerks process curbside voters by bringing the voting equipment outside to the voter's vehicle. This includes:

- Bringing the Resolution ePollbook to the voter's vehicle to check them in.
- Returning the ePollbook to the Resolution Table to print the voter's Ballot Card.
- Lifting the Ballot Marking Device (BMD) onto the Curbside Cart and transporting it outside to the voter's vehicle.
- Returning the BMD and voter's completed Ballot to inside the polling location to cast the Ballot and put away the equipment.

Curbside Clerks complete other necessary duties in the polling location, same as the other Clerks, when they are not processing a curbside voter.

Do voters have to reapply for Ballot by Mail every year?





Yes, eligible voters who wish to vote by mail must reapply every calendar year by submitting an Application for Ballot by Mail (ABBM). All ABBMs expire on December 31st of the year in which they are submitted. This is true for both Annual and Nonannual applications.

Annual applications are only available to voters 65 and older and voters with disabilities. If a voter is voting by mail on the grounds of confinement in jail, pregnancy or an expected absence from the county during the election period, they are eligible to submit a Nonannual application for one election and its resulting runoff.



- Preparing the Call Center



Did you know that when there is a change made to the voting system (new questions, forms, colors, etc.), the devices are put through a rigorous testing phase conducted by the Texas Secretary of State's office? This testing is conducted on all voting systems in Texas prior to their use by counties. You will see some small changes to workflows and procedures on the ePollbook in the upcoming election, which we'll mention next month in the Gazette and cover in detail in your training class.

With a bit over a month until early voting, the Travis County Elections ePollbook team has already begun preparing for the upcoming election. At this stage, we are preparing the contents of the orange and yellow kits that are deployed to each of the voting locations. This period of time, consisting of multiple tests and configuration changes, is used to ensure accuracy and consistency for the equipment being deployed. Over the coming weeks, our team will be coordinating closely with the other Elections Division departments, all working toward the goal of a successful election. We are looking forward to working with you and seeing you next month!

Our Travis County Elections ADA Team began one year ago and since then they have worked tirelessly to ensure that our polling locations are as accessible as possible for all voters. We interviewed them to hear what their experience was like in this first year.

What was your favorite memory of working on the ADA Team this year?



Tim: "When we hit the 200 site surveys mark!"



Dan: "Working with the other ADA Coordinators!"



John: "One of my favorite memories was during a site survey, someone who worked at the church we were surveying helped us by doing stuff like holding our tape measure. It was really nice!"

What was something unexpected that you learned or experienced this year?

Destini: "Something I didn't expect when I joined the ADA Team was how many places in Austin don't have flat parking and how many gaps and level changes on city sidewalks needed to be filled."



What was the most challenging part, and most rewarding part, of this year?



Tim: "The most challenging part was the heat of the summer when we were surveying sites. The most rewarding part is when the sites are all confirmed for an election. It is a lot of work, so we celebrate every step we can!"



Dan: "The most challenging part was surveying all the polling sites, especially because we were just learning along the way. The most rewarding part was learning what it takes for things to be accessible and how to go about doing that. It was also great to see the support from other election staff members as they helped us integrate into the team."



John: "The most challenging part was surveying sites when it was 100 degrees in the summer, and also when it was rainy or cold in the fall. The most rewarding part was being able to go to every site and complete all of the surveys."



Destini: "The most challenging part of the year was meeting our March 1st deadline to upload all the surveys of the sites we used during the 2022 calendar year to the Department of Justice. The most rewarding part about this year was seeing how many sites took our feedback and either repaved their whole parking lot, filled gaps or fixed any level changes, or made doors more accessible. Seeing that our job really does pay off, seeing how far Travis County would go to ensure that all voters get the same voting experience, and not putting a limit on our voters who are disabled was very rewarding."



Have you ever wondered what a day is like in our different departments and teams within the Elections Division? This month, we'll get a peek into a day in the life of our Voting Equipment Technicians (VETs) as they prepare for Early Voting and Election Day.

- Preparation and Configuration of Voting Equipment

Voting Equipment Techs (VETs) prepare the Ballot Marking Devices and Scanners for Early Voting (EV) by performing basic maintenance tasks, loading the current election, testing the equipment with paper ballots to make sure they print and read correctly, and then adding security seals. EV equipment is prepared first, and then the VETs transition to the preparation of voting equipment for Election Day (ED).

- Delivery and Setup of Early Voting Polling Locations

Prior to the start of Early Voting, VETs in teams of two meet with the EV Deputies at each polling location by appointment to assist with setup of the location. Prior to the scheduled appointments, a separate group of VETs perform the delivery of Election Supply Carriers (ESCs), scanners, and ADA equipment to each EV polling location. It should be noted that VETs generally are not able to assist with setup of ED sites due to the large number of locations involved.

- Technical Support and Resupply During Early Voting Period

During EV, VETs provide technical support and resupply of consumable items (blank ballot cards, forms, etc.) to all polling locations within their assigned routes. Routes are sized to enable VETs to visit each of their assigned polling locations several times during each shift, during which time they will observe for correct signage and electioneering activities, ensure that the locations are processing voters at an efficient rate, and provide technical support and supplies as needed. VETs are scheduled to support two shifts daily, with the AM shift running 5:30am to 1:00pm, and the PM shift running 12:30pm to approximately 8:00pm, depending on when polling locations close. PM shift VETs are tasked to remain in their routes until all their assigned polling locations have closed successfully for the day.

- Early Voting to Election Day Conversion for Polling Locations

Upon completion of Early Voting, VETs will assist in converting EV sites to ED sites by replacing the scanners, replenishing supplies, reconfiguring the ePollbooks from EV to ED, and cleaning up the location as needed. Note that most, but not all, of the EV polling locations also serve as ED locations.





Q: Is there a new version of the Poll Worker Training Manual?

A: Yes! It is very important that you use the new version of the Poll Worker Training Manual for this election. There have been several changes to procedures, which you'll hear about in your training class in the coming weeks. There have been other changes to the Poll Worker Training Manual as well, including additions about ADA, updated photos, and more.

If you are a Deputy or Alternate Deputy for Early Voting, or a Judge or Alternate Judge for Election Day, you can access the manual in one of three ways:

- 1. If attending an **in person training class**, you will receive your manual at class.
- 2. If attending an online webinar training, you may pick up your manual at the Elections Office (5501 Airport Blvd) during office hours.
- Access the manual anytime online on the Online Elections Training Center.

There will be one Poll Worker Training Manual in every site's Forms Box that all Poll Workers can reference. Everyone can also access the manual online on the Elections Training Center as well.

We look forward to seeing you at Training class this month!



TIPS from the Trainers

Addressing the "Address Not in Election" Flag

This election is <u>not</u> a county-wide election, which means that some Travis County voters will not have anything to vote on, depending on the address at which they are registered. If a voter comes to your polling place but does not reside in a jurisdiction holding an election, a red **ADDRESS NOT IN ELECTION** flag will appear on the Voter Eligibility screen.

If the voter has any questions or contests our records, direct them to the Resolution Table where the Deputy/Judge can call the Call Center to initiate further research.

ePollbook Reminders

REMEMBER, MIFI FIRST!

Remember to power up the MiFi before any other ePollbook equipment because it will help with connectivity.

If the MiFi is already on, then a freshly powered up ePollbook will find the network much easier.



Below, see photos of the side of the ePollbook that show where the power cord should be plugged in. A common problem is that poll workers accidentally put the cord into a small gap between the ePollbook and the case, rather than into the ePollbook charging port.

If someone accidentally does this and doesn't realize it, the battery of their ePollbook could die. It is important to keep the ePollbook plugged in so that it will have power for the entire day.







ELECTIONS STAFF SPOTLIGHT

Caitlin started working for Travis County Elections in 2011 as a Receiving Substation (RSS) worker. Her knowledge of procedures and statistics led her to become a training and Call Center worker from 2012 – 2020. Caitlin took a break from the elections world and worked as a 911 call taker for the Travis County Sherriff's Office. Upon her return in 2021, she was hired for a full-time position as a Training Coordinator.

Caitlin was born in Abilene, TX and lived in various places throughout her childhood. She came to Austin, TX in 2008 to attend the University of Texas. She finished with a degree in Communication Studies in 2019, As a Training Coordinator, she has been able to put her degree to work as she provides much insight to the procedures for use of voting equipment, as well as providing input to State programs such as the Risk-Limiting Audit pilot program.

Risk Limiting Audit Pilot Program



Caitlin Arzate Training Coordinator

In 2021, the Texas Legislature passed SB598, which requires risk-limiting audits be conducted for all elections beginning in 2026. Travis County Elections previously conducted a pilot RLA in 2019 and is actively participating in the Secretary of State's Risk-Limiting Audit Pilot Program.

A risk-limiting audit is just one type of post-election audit. In Travis County, we use the ballot polling method where audit teams hand-tally a random sample of ballots from all ballots cast in the election. Then they compare the selections on those ballots to the reported overall results.

Why do we use random ballots?

The best way to understand why we audit random ballots is to use a metaphor from the leading RLA expert Philip B. Stark.

Think about the last time you cooked soup. The last step of the recipe says "salt to taste" so you add a little salt. Right away. we can make a couple observations that apply to audits:

- If you taste a spoonful without stirring, it's either too salty or not salty enough.
- After stirring, you don't need to eat the whole soup to know whether it's too salty.
- It doesn't matter how big the pot is, one spoonful is enough!

As you're reading this, we have all the ingredients for a successful RLA of the recent local election. We have:

- all the ballots cast in Travis County our soup!
- secure and organized ballot storage;
- chain-of-custody tracking paperwork;
- a ballot manifest -a record of every ballot and where it's located.

Now that we've taken all the steps to prepare, the audit itself is incredibly straightforward:

- 1. We use a random number generator and the ballot manifest to select ballots randomly from all ballots cast - our spoonful!
- 2. The randomly selected ballots are located and retrieved.
- 3. Selections from the random ballots are hand-tallied.
- 4. The hand-tallied counts are compared to the overall results.
- 5. The audit stops when a statistically pre-determined number of votes are counted for the winner compared to the loser(s).

This type of post-election audit is statistically designed to verify reported results with the fewest number of manually counted ballots possible - way more efficient than a full recount! For the November 2022 RLA we only had to audit 74 ballots!

If you're still reading, BRAVO! and thank you! If you want to read more, a great place to start is Mark Lindeman and Philip B. Stark's Gentle Introduction and their longer paper about the ballot polling method linked at the top of the paragraph.

- After a rather slow start, turnout rallied on the last two days of Early Voting and Election Day. Once again, Ben Hur Shrine Center had the highest turnout with 6,052 voters during Early Voting, almost twice the turnout of the next nearest sites (Austin Oaks Church, Balcones Woods Shopping Center, and Randalls Flagship Westlake Hills). And yes, Ben Hur was #1 on Election Day as well...by a long shot.
- Let's salute ALL the sites for being there for the Travis County voters that needed them. In a non-county-wide election, with isolated entities and polling sites such as Hays CISD (Creedmoor Community Center), Village of Webberville (Dailey Middle School), and City of Elgin (ACC Elgin Campus), poll workers sit there for the same 12 hours to serve the voters of their smaller communities. Hats off.

Training for Call Center Representatives

Elections Call Center. How may I help you?

Election season is a very busy time for everyone in the Call Center. Each call is unique, yet we can predict and train for the types of questions the caller will have. Some calls are not for the Elections Division at all and are transferred to the appropriate department. For Election calls, we begin training 3 weeks before Early Voting begins on the newest Election Laws passed by the State Legislature and voting procedures. We review jurisdiction boundary lines to determine if a voter qualifies for a Limited Ballot. We verify voter's registration status, find their nearest polling location, and help them preview their sample ballot.

Calls from Poll Workers

As poll workers, you know about most of our conversations. If you can't find a voter, call the Call Center and we will connect you with Voter Registration. If your report isn't printing, call the Call Center and we will connect you with the ePollbook team. If you need more "I Voted" stickers or Statements of Residence or if your Ballot Marking Device is stuck on its bootup screen, call the Call Center and we will dispatch your Voting Equipment Technician. Call us when you are open for voting at the beginning of the day and when your last voter has finished voting at the end of the night.

- Calls from Ballot by Mail Voters

Vote by Mail voters reach out to our office to request an Application for Ballot by Mail (ABBM) be mailed to them, to verify that their ABBM was received, to confirm that we mailed their ballot, or if we received their voted ballot. Other times, we call the voter if they forget to sign or include their ID numbers on their Carrier Envelope or if they left their driver's license at the polling location.



How many calls did the Call Center answer in the last election?






Risk Limiting Audit Recap



Last month we introduced you to risk-limiting audits and were deep into preparing for a pilot audit for the recent May local election. So how did our risk-limiting audit go?


It was a success! We had 10 people audit 69 unique ballots over 2 separate rounds. The pilot took just 4 total hours to complete. For this pilot, we selected City of Austin's Propositions A & B as the contests to be audited.




Our goal was to really test our readiness, so we set a strict risk-limit of 1%. This meant we stood a pretty good chance of not completing the audit in a single round. That's because the stricter the risk-limit, the more evidence (aka votes for the winner) we'll need to see to meet the limit's confidence-level.

But what does that actually mean?

Generally speaking, auditing a ballot with a vote for the winner <u>adds</u> confidence that our overall reported result is correct, and auditing a ballot with a vote for any loser <u>detracts</u> from our confidence in our reported results.



Check out the votes for the 21 ballots audited in Round 1:



Here's how auditing those ballots one at a time either adds to or takes away from our overall confidence:



As you can see, we didn't meet the 1% risk-limit for either contest by the last ballot in Round 1. During Round 2 we audited 48 more unique ballots. Here's how Round 2 went:



With this pilot audit, we strengthened our existing procedures and developed some new ones. We know that we're ready for the statewide audits coming in 2026!






EARLY VOTING BALLOT BOARD & SIGNATURE VERIFICATION COMMITTEE



To meet the volume of ballots and the required deadlines, the Early Voting Ballot Board (EVBB) and Signature Verification Committee (SVC) each play an integral role in qualifying and processing voted mail ballots. Members serving on EVBB are different from those on SVC to incorporate multiple layers of review, promoting transparency and integrity of the process. This is conducted under 24/7 live stream video per the election code. Our office, the Early Voting Clerk (EVC), supports both groups in ensuring all eligible absentee votes in the county are counted.

Signature Verification Committee (SVC)

The Early Voting Clerk receives, and preps voted ballots for SVC who conducts the first round of verification. SVC is comprised of at least five members where a Committee Chair is the administrative authority. Bipartisan teams of two will verify voters' signatures and identification numbers. They do this by comparing carrier envelopes to their corresponding Voter Registration records. SVC does not open carrier envelopes but will process ballots either as pre-accepted or to be placed on hold. Ballots in hold status will be worked by the Early Voting Clerk support staff to initiate cure process if applicable.



Early Voting Ballot Board (EVBB)

Accepted ballots are then transferred to EVBB. EVBB consists of a presiding judge and at least two other members of each major party. They qualify ballots voted by mail as well as provisional ballots. EVBB will open and separate accepted ballot and carrier envelopes and prepare them for delivery to Central Count Station (CCS) for final tabulation. EVBB also checks for supplemental paperwork such as Statement of Residence forms.

In 2022, the Travis County Clerk's office held its first "I Voted" sticker design contest. The Birth of Early Voting in Texas

- Prior to 1987, the only reason a Texas voter would be permitted to vote early would be to appear at the County Election Office with a valid excuse as to why they would not be in their home county on Election Day. Then, in 1987, the Texas Legislature passed the Extended Voting Law, giving all Texas voters the option to cast a "no-excuse absentee ballot." What is now known as Early Voting was born.
- The first major Election to feature this new "early voting option" was the 1988 Primary where Texas voters had 17 days (February 21 March 9) to vote early. At that time, Early Voting could only take place at the County's Election Office.
 - In 1991, the law was amended to allow Counties to establish "Temporary Branch Locations" so that voting could take places such as grocery stores and other places convenient to voters.

What are the new election-related legislative changes going into effect?

Jonathan William Operations Coordinator

SB 477

Makes changes to better accommodate votes with disabilities (voting priority and curbside specific parking).

(Section 63.0015) Priority processing: An election officer shall accept a person with a mobility problem that substantially impairs a person's ability to ambulate who is offering to vote before accepting others offering to vote at the polling place who arrived before the person. (This also includes a people assisting that voter)

The Notice of Voting Order Priority shall be posted in the kiosk, where people in line can see it.

(Section 64.009) Accommodations for voters with disabilities will be posted on the County Clerk's website.

Two parking spots for voters not entering the voting site (curbside) now required. These cannot be ADA designated spots.

SB 1089

Unopposed candidates will appear on the ballot. The result will be a longer ballot in certain elections.

SB 1599

Allows Ballot By Mail voters to correct certain defects in their BBM application via mail, in addition to correcting the defect in person or by using the SOS on-line ballot by mail tracker.

HB 357

SOS now sets the date for May and November runoff elections.

HB 1243


Penalty for illegal voting reverted from a class A misdemeanor to a felony penalty.

HB 1631

Poll Watchers can come and go on ED and do not need to be there for a minimum of 5hrs anymore.









ADA PARKING

KNOWLEDGE KNOCKOUT

Become an expert at voter accessibility

Curbside spaces are for voters who are **not entering** the polling site to vote. Texas

Election Code requires that curbside spaces **can not** be spaces designated as ADA

parking.



ADA spaces are for voters who **do want to enter** the polling site to vote. Federal law requires a specific number of ADA spaces for the total number of spaces in a parking lot. (1 for every 25 up to 100 spaces with at least 1 van accessible space)

Curbside spaces should be on a route accessible by poll workers and can be in existing non-ADA spaces.




ADA spaces should be on the shortest route to the entrance of the voting site and must be on level, firm and slip resistant ground.

Texas Election Code (§64.009) requires curbside voting as of Sept. 1, 1997.



Federal law (ADA of 2010) requires accessible parking for all public facilities. (Voting sites are considered public facilities)


Texas Election Code requires 2 spaces for curbside voting at every voting site.



In honor of that *new clothes* feeling, let's go over the dress code for poll workers.

To summarize, the dress code emphasizes comfort and professionalism. Basically, we'd like you to **be comfortable and also professional.** That is it. Also, please remember to wear closed toed shoes in training class and in the polling place. Instead of going over all of the ways you can be comfortable and professional, we've listed the types of clothes and accessories that are <u>not</u> appropriate below:

- Shorts, flip flops, or tank tops
- Oversized shirts or baggy pants
- Shirts with elongated armholes or low cut necklines
- Pajamas or slippers
- See-through or overly tight-fitting clothing
- Backless, spaghetti strap, strapless or halter-style tops
- Visible Undergarments
- Ripped or torn clothing
- Excessive amounts of visible jewelry, make-up, tattoos or piercings
- Clothing/accessories that promote candidates, controversial issues or have vulgar/obscene images or words
- · Clothing that requires frequent adjustment to keep it from being too revealing

Those of you who have worked elections for the last couple of years are likely already familiar with the Legally Required Signs and Postings packet sent to you by your Sites Department. It looks a bit like a hazmat warning (bright orange for EV, bright pink for EDAY); Early Voting Deputies receive them at set-up and Election Day Judges receive them at Supply Pickup. As the name suggests, it contains LEGALLY required postings for your polling site, such as "Four Nearest Polling Sites" and "Notice of Voting Order Priority," but it's so much more than that! It includes all kinds of relevant polling site information including:

- Parking
- Curbside Voting
- Building Access
- ADA Remediation Checklist
- Site setup information
- Sign map with outdoor sign placement suggestions
- Voter Exit and Entrance signs
- Other site-specific signs with instructions about where they go







- Any poll worker who is resolving an issue can call the Call Center, not just the Deputy/Judge.
- Keep the Travis County cell phone fully charged with the ringer volume at the highest setting.
- Please keep the phone connected to the charger where it can be easily accessible.
- Make sure to share your phone number with the call center if you prefer to use your own device.
- · Avoid using the speaker phone unless directed by the Call Center. Some information is sensitive in nature and is only meant to be shared with you (and other election heroes).
- When in doubt, please call the Call Center! Procedures change every Legislative session and we want to follow Election law.

INTERVIEW WITH Paul DeLaRosa

Call Center Coordinator

Can you tell us a little bit about your journey here at Travis County Elections?

HALLOWEEN DURING EARLY VOTING







IT'S A TREAT HAVING SUCH AMAZING ELECTION WORKERS!

- Before you arrive, please make space in your vehicle for your supplies.
- Once you arrive at 5501 Airport Blvd please place your car in park and stay inside. If your trunk opens automatically, let us know!
- Have your Writ and the name of your Election Polling Site handy.
- Be ready to show your Driver's License or ID Card when we arrive at your car.
- Due to the high volume of cars, please keep conversations to a minimum. We want to make sure all of you are supplied in a timely and organized manner.
- Please do not leave any supplies in your car overnight unless you park in a garage.
- When you get home, be sure to charge the provided cell phone. In the morning, put both the cell phone and the charger back into its bag.
- On the morning of Election Day, be sure to bring all of the supplies into your polling site. Check your vehicle to make sure nothing is left behind.
- Do a thorough inventory of all the supplies you received to make sure your important memos, legally required signs, and all postings packets reflect your assigned polling site. If there are any missing supplies or forms, please notify the Call Center as soon as possible!
- If for any reason you are unable to make it to 5501 Airport Blvd during your allotted time for supply pick-up, don't worry! We can make other arrangements as long as you give us a call.
- · Get plenty of rest before Election Day!


