

**ORDER CALLING DIRECTORS ELECTION  
FOR LOST CREEK LIMITED DISTRICT**

WHEREAS, Lost Creek Limited District (the “*District*”) is a political subdivision of the State of Texas, created effective December 15, 2015 pursuant to the terms of an Amended and Restated Strategic Partnership Agreement entered into by Lost Creek Municipal Utility District and the City of Austin dated March 12, 2013 pursuant to the authority set forth in Section 43.0751 of the Texas Local Government Code;

WHEREAS, Section 49.103 of the Texas Water Code provides that an election for directors of a district shall be held on the uniform election date, established by the Election Code, in May of each even-numbered year to elect the appropriate number of directors;

WHEREAS, pursuant to the authority set forth in Section 41.0052 of the Texas Election Code, the Board of Directors of Lost Creek Municipal Utility District previously adopted Resolution No. 11-1220-01 changing its general election from the uniform election date in May to the uniform election date in November of each even-numbered year;

WHEREAS, the uniform election date for the election of two (2) directors of Lost Creek Municipal Utility District is therefore November 5, 2024; and

WHEREAS, Section 31.092(a) of the Election Code authorizes the governing body of a political subdivision to contract with the county election officer to perform election services in any election ordered by the political subdivision;

WHEREAS, Section 271.002 et seq. of the Election Code authorizes joint elections to be held by certain entities, including two or more political subdivisions in all or part of the same territory, provided the governing bodies enter into an agreement to hold the election jointly;

WHEREAS, pursuant to Section 271.003 of the Election Code, a regular county polling place may be used for a common polling place in a joint election, and the voters of a political subdivision may be served in a joint election by a common polling place outside the boundary of the political subdivision if the location can adequately and conveniently serve the affected voters and will facilitate the orderly conduct of the election;

WHEREAS, Section 42.0621 of the Election Code provides that in an election held on the November uniform election date, certain political subdivisions (including the District) must use the regular county election precincts;

WHEREAS, the Board of Directors of the District, in an open, public meeting, proper notice of which has been given as required by law, has given consideration to calling a directors election for November 5, 2024; and

WHEREAS, the Board of Directors desires to proceed with the ordering of said director election. NOW, THEREFORE,

BE IT ORDERED BY THE BOARD OF DIRECTORS OF LOST CREEK LIMITED DISTRICT THAT:

Section 1: The matters and facts set out in the preamble of this Order are hereby found and declared to be true and correct.

Section 2: An election shall be held for the District between the hours of 7:00 a.m. and 7:00 p.m. on the 5th day of November 2024, in Travis County, Texas, in the event the election is not cancelled as permitted by law, at the places listed on **Exhibit “A”**, being the polling places established by Travis County to serve the county’s regular election precincts within the District, as required by Section 42.0621 of the Texas Election Code. The polling locations designated on **Exhibit “A”** may be changed from time to time to reflect any changes to the County election precincts and polling locations established by Travis County. The Travis County Election Administrator is conducting the election pursuant to an Election Agreement (the “*Election Agreement*”) between the District and Travis County. The election shall be held as a joint election pursuant to Chapter 271 of the Texas Election Code. Travis County’s election equipment shall be used in the election. After duly considering the requirements of the Texas Election Code, the Board finds said polling places established by Travis County to be proper places for conducting the election. The Board of Directors specifically finds that such locations can adequately and conveniently serve the affected voters of the District and will facilitate the orderly conduct of the election.

Section 3: The Travis County Election Administrator is hereby appointed as the officer of said election.

Section 4: Early voting shall be conducted at the early voting polling locations identified on **Exhibit “B”** attached hereto. The Board authorizes and approves any changes to said exhibit necessary to reflect changes to early voting polling locations established by Travis County. These places shall remain open on the dates and at the times set forth in **Exhibit “B”**. The Travis County Election Administrator is hereby appointed as the Early Voting Clerk. Early voting shall commence on October 21, 2024 and continue through November 1, 2024, all as provided by the Texas Election Code. The Early Voting Clerk’s mailing address to which ballot applications and ballots to be voted by mail may be sent is Travis County Clerk - Elections Division, P.O. Box 149325, Austin, TX 78714-9325 or by electronic mail to: [ebbm@traviscountytexas.gov](mailto:ebbm@traviscountytexas.gov) or by facsimile to: (512) 854-3969. Any person that submits an application for a Ballot by Mail by fax or email must also be submitted by mail and received within four business days of the electronic submission.

Section 5: An Early Voting Ballot Board is hereby created to process early voting results. The early voting ballot board presiding judge and alternate presiding judge shall be appointed in accordance with the Election Agreement and the Texas Election Code.

Section 6. All resident, qualified electors of the District shall be entitled to vote at the election.

Section 7. Written application to have a person's name printed on the ballot as a candidate for the office of director of the District, signed by the candidate must be received by the Secretary of the Board of Directors of the District not later than 5:00 p.m. on Monday, August 19, 2024. No person's name shall be placed on the ballot unless he or she is at least eighteen (18) years of age, a citizen of the United States, a resident of the State of Texas, either owns land subject to taxation in the District or is a qualified voter within the District, and otherwise satisfies the qualifications for holding a public office contained in the Texas Election Code. No person who is disqualified by the laws of the State of Texas from serving as a director of this District shall have his or her name placed on the ballot. The Secretary is authorized to determine the qualifications of candidates for office. If the Secretary determines that an applicant is not qualified, it shall give written notice to the applicant of the reason for the rejection. Jim Emmons, General Manager of the District, is hereby appointed as the District's agent to perform various election duties for the election, including maintaining in such agent's office at 1305 Quaker Ridge Road, Austin, Texas 78746, the documents, records, and other papers relating to the election that by law are placed in the custody of the Board of Directors and that are public information. The agent shall receive any personally delivered document relating to the election that the Board of Directors is authorized or required to receive and shall make available for inspection and copying, in accordance with the applicable statutes and regulations, the documents, records, and other papers that are required to be maintained in the agent's office and may perform any other ministerial duties in connection with the election that may lawfully be performed by an employee of the District.

Section 8. Declarations of write-in candidacy must be received by 5:00 p.m. on Friday, August 23, 2024.

Section 9: When the number of candidates to appear on the ballot exceeds the number of offices to be filled, the order in which the names of the candidates are to be printed on the ballot shall be determined by a drawing to be conducted by the Secretary (or his or her designated agent). The Secretary shall post notice within the District, at least seventy-two (72) hours prior to the time at which the drawing is to be held, of the time and place of the drawing, and shall also mail notice of the date, hour, and place of the drawing to each candidate, at the address stated on the candidate's application for a place on the ballot, not later than the fourth day before the day of the drawing. Each candidate involved in the drawing or a representative designated by the candidate shall have a right to be present and observe the drawing.

Section 10: Pursuant to Section 49.103(h), Texas Water Code, the Secretary, upon receipt of certification that each candidate whose name is to appear on the ballot is unopposed, is authorized to post notice that the election is not to be held at the polling place that would have been used at the election. The notice of cancellation shall be posted on or before the commencement of early voting.

Section 11: Voting shall be by the use of direct recording electronic system. The Travis County Voter Registrar may utilize a central counting station as provided by Section 127.001 *et*

*seq.* of the Texas Election Code. The ballots used in the election shall have printed thereon the names of the candidates for the office of director and two (2) blank spaces for write-in votes. The voter may vote for none (0), one (1), or two (2) persons for director by placing an “X” in the square beside the person's name or by writing the name or names of a person or persons in the blank spaces provided. Oral assistance in Spanish shall be made available to all persons requiring such assistance. Any person requiring oral assistance in Spanish should contact the presiding judge or early voting clerk.

Section 12: In accordance with Section 4.003(a) of the Texas Election Code, the General Manager or other representatives of the District shall cause the notice to be given by any one or more of the following methods: (i) by publication one time, not earlier than the 30th day or later than the 10th day prior to the date set for the election, in a newspaper published in the District or, if none is published in the District, in a newspaper of general circulation in the District; (ii) by posting in accordance with the Texas Election Code not later than the 21st day before the election in each election precinct that is in the jurisdiction of the District; or (iii) by mailing, not later than the 10th day before election day, a copy of the notice to each registered voter of the territory that is covered by the election and is in the jurisdiction of the District.

In accordance with Section 4.003(b) of the Election Code, not later than the 21<sup>st</sup> day before the election, notice of the election shall be posted on the bulletin board used for posting notices of the meetings of the Board of Directors of the District.

Prior to 60th day before Election Day, the General Manager shall deliver notice of the election to the Travis County election officer and voter registrar in accordance with Section 4.008 of the Election Code.

Notice of the election may also be furnished by any other manner of notice authorized by law.

Section 13: The election shall be held and conducted and returns made to this Board of Directors in accordance with the Texas Election Code, as modified by the applicable provisions of Chapters 49 and 54, Texas Water Code.

Section 14: The rate of pay for judges and clerks of the election shall be determined by the Travis County Elections Administrator.


Section 15: The President and Secretary, and the District’s legal counsel, are authorized and directed to take any action necessary to carry out the provisions of this order.

EN VISTA DE QUE, de acuerdo con la autoridad establecida por la Sección 41.0052 del Código Electoral de Texas, la Junta Directiva del Distrito de Servicios Públicos Municipales de Lost Creek adoptó previamente la Resolución nro. 11-1220-01 que cambia su elección general de la fecha de elección uniforme de mayo a la fecha de elección uniforme de noviembre de cada año par;

EN VISTA DE QUE, la fecha de elección uniforme para la elección de dos (2) directores del Distrito de Servicios Públicos Municipales de Lost Creek es, por lo tanto, el 5 de noviembre de 2024; y

EN VISTA DE QUE, la Sección 31.092(a) del Código Electoral autoriza al órgano de gobierno de una subdivisión política a celebrar un contrato con el funcionario electoral del condado para prestar servicios electorales en cualquier elección convocada por la subdivisión política;

EN VISTA DE QUE, la Sección 42.0621 del Código Electoral dispone que en una elección celebrada en la fecha de elección uniforme de noviembre, ciertas subdivisiones políticas (incluido el Distrito) deben usar los precintos electorales regulares del condado;

EN VISTA DE QUE, la Junta Directiva del Distrito, en una asamblea pública y abierta, de la cual se dio aviso debido según lo exige la ley, ha considerado convocar una elección de directores para el 5 de noviembre de 2024; y

EN VISTA DE QUE, la Junta Directiva desea proceder con la orden de dicha elección de directores. AHORA, POR LO TANTO,

LA JUNTA DIRECTIVA DEL DISTRITO LIMITADO DE LOST CREEK ORDENA:

Sección 1: Por la presente, los asuntos y hechos establecidos en el preámbulo de esta Orden son hallados y declarados verdaderos y correctos.

Sección 2: Se celebrará una elección para el Distrito en el horario de 7:00 a.m. a 7:00 p.m. el día 5 de noviembre de 2024 en el Condado de Travis, Texas, en caso de que la elección no se cancele según lo permite la ley, en los lugares indicados en el **Anexo “A”**, siendo estos los lugares de votación establecidos por el Condado de Travis para atender a los precintos electorales regulares del condado dentro del Distrito, según lo exige la Sección 42.0621 del Código Electoral de Texas. Los lugares de votación designados en el **Anexo “A”** pueden cambiar de vez en cuando para reflejar cualesquier cambios en los precintos electorales y lugares de votación del Condado establecidos por el Condado de Travis. El Administrador de Elecciones del Condado de Travis está llevando a cabo la elección en conformidad con un convenio electoral (el “*Convenio Electoral*”) entre el Distrito y el Condado de Travis. La elección se llevará a cabo como una elección conjunta en conformidad con el Capítulo 271 del Código Electoral de Texas. En la elección se usará el equipo electoral del Condado de Travis. Después de considerar debidamente los requisitos del Código Electoral de Texas, la Junta halla que dichos lugares de votación establecidos por el Condado de Travis son adecuados para celebrar la elección. La Junta Directiva específicamente halla que dichos lugares pueden atender de forma adecuada y conveniente a los votantes afectados del Distrito y que facilitarán la celebración ordenada de la elección.

Sección 3: Por el presente se designa al Administrador de Elecciones del Condado de Travis como oficial de dicha elección.

Sección 4: La votación anticipada se llevará a cabo en los lugares de votación anticipada identificados en el **Anexo “B”** adjunto al presente documento. La Junta autoriza y aprueba cualesquier cambios a dicho anexo que sean necesarios para reflejar cambios en los lugares de votación anticipada establecidos por el Condado de Travis. Estos lugares deberán permanecer abiertos en las fechas y horarios indicados en el **Anexo “B”**. Por la presente, se designa al Administrador de Elecciones del Condado de Travis como Oficial de Votación Anticipada. La votación anticipada comenzará el 21 de octubre de 2024 y continuará hasta el 1 de noviembre de 2024, inclusive, de acuerdo a las disposiciones el Código Electoral de Texas. Toda persona que envíe una solicitud de boleta para votar por correo a través del fax o del correo

electrónico, también debe enviarla por correo postal y esta debe recibirse en el plazo de los cuatro días hábiles del envío electrónico.

Sección 5: Por la presente, se establece un Consejo de Boletas de Votación Anticipada para procesar los resultados de la votación anticipada. Se designará al juez presidente y al juez presidente alterno del consejo de boletas de votación anticipada en conformidad con el Convenio Electoral y el Código Electoral de Texas.

Sección 6: Todos los votantes habilitados, residentes del Distrito tendrán derecho a votar en la elección.

Sección 7. La solicitud por escrito para que se imprima el nombre de una persona en la boleta como candidato para el cargo de director del Distrito, firmada por el candidato, debe ser recibida por el Secretario de la Junta Directiva del Distrito a más tardar a las 5:00 p.m. del lunes 19 de agosto de 2024. No se colocará en la boleta de votación el nombre de ninguna persona a menos que tenga dieciocho (18) años de edad, sea ciudadano de Estados Unidos, sea residente del Estado de Texas, o bien sea propietario de terreno sujeto a impuestos en el Distrito o sea un votante habilitado dentro del Distrito y de algún otro modo cumpla con los requisitos del Código Electoral de Texas para ocupar un cargo público. No se colocará en la boleta de votación el nombre de ninguna persona que haya sido descalificada por las leyes del Estado de Texas para fungir como director de este Distrito. El Secretario está autorizado a determinar los requisitos de los candidatos para el cargo. Si el Secretario determina que un solicitante no cumple con los requisitos, le enviará un aviso escrito a dicho candidato con el motivo del rechazo. Por la presente, se designa a Jim Emmons, Administrador General del Distrito, como agente del Distrito para realizar diversas obligaciones electorales para la elección, como el mantenimiento de los documentos, expedientes y otra papelería relacionada con la elección en la oficina de dicho agente, ubicada en 1305 Quaker Ridge Road, Austin, Texas 78746, los cuales se han puesto bajo la custodia de la Junta Directiva y son información pública. El agente recibirá cualquier documento entregado personalmente relacionado con la elección que la Junta Directiva esté autorizada u obligada a recibir, y pondrá a disposición para inspección y copiado, en conformidad con los reglamentos y leyes correspondientes, los documentos, expedientes y otra papelería que deban mantenerse en la oficina del agente y puede llevar a cabo cualquier otra obligación ministerial en relación con la elección que pueda realizar legalmente un empleado del Distrito.

Sección 8. Se deben recibir las declaraciones de candidatura por escrito, a más tardar, a las 5:00 p.m. del viernes 23 de agosto de 2024.

Sección 9: Cuando la cantidad de candidatos que deben aparecer en la boleta de votación supere la cantidad de cargos a ocupar, el orden en el cual se imprimirán los nombres de los candidatos en la boleta de votación será determinado mediante un sorteo realizado por el Secretario (o su agente designado). El Secretario colocará un aviso en el Distrito, al menos setenta y dos (72) horas antes del horario programado del sorteo, con el horario y el lugar del sorteo, y además enviará por correo un aviso con la fecha, la hora y el lugar del sorteo a cada candidato, a la dirección indicada en la solicitud de un lugar en la boleta del candidato, a más tardar el cuarto día antes del

día del sorteo. Todo candidato participante en el sorteo, o un representante designado por el candidato, tiene derecho a estar presente y observar el sorteo.

Sección 10: De acuerdo a la Sección 49.103(h) del Código de Agua de Texas, el Secretario, al recibir una certificación de que cada candidato cuyo nombre aparecerá en la boleta de votación no presenta oponentes, está autorizado a colocar un aviso de que la elección no se llevará a cabo en el lugar de votación que se habría usado en la elección. El aviso de cancelación se debe colocar el día del inicio de la votación anticipada, o antes de esa fecha.

Sección 11: La votación se efectuará mediante el uso de un sistema electrónico de registro directo. El Registrador de Votantes del Condado de Travis puede usar una estación central de conteo de acuerdo con lo dispuesto por la Sección 127.001 y siguientes del Código Electoral de Texas. Las boletas usadas en la elección tendrán impreso los nombres de los candidatos para el cargo de director y dos (2) espacios en blanco para votos por escrito. El votante puede votar por ninguna (0), una (1) o dos (2) personas para director colocando una "X" en la casilla junto al nombre de la persona o escribiendo el nombre de la persona o las personas en los espacios en blanco provistos. Habrá asistencia verbal en español disponible para todas las personas que la requieran. Cualquier persona que necesite asistencia verbal en español se deberá comunicar con el juez presidente o con el oficial de votación anticipada.

Sección 12: En conformidad con la Sección 4.003(a) del Código Electoral de Texas, el Administrador General u otros representantes del Distrito darán aviso mediante uno o más de los siguientes métodos: (i) la publicación, una sola vez, no antes del trigésimo día ni después del décimo día anterior a la fecha establecida para la elección, en un periódico publicado en el Distrito o, si no hay ninguno que se publique en el Distrito, en un periódico de circulación general en el Distrito; (ii) la colocación, en conformidad con el Código Electoral de Texas, a más tardar el vigésimo primer día antes de la elección, en cada precinto electoral que esté dentro de la jurisdicción del Distrito; o (iii) el envío por correo postal, a más tardar el décimo día antes del día de elección, de una copia del aviso a cada votante registrado del territorio en el que se realiza la elección y que esté dentro de la jurisdicción del Distrito.

En conformidad con la Sección 4.003(b) del Código Electoral, a más tardar el vigésimo primer día anterior a la elección, se debe colocar el aviso de la elección en el tablero de anuncios que se utiliza para colocar los avisos de las asambleas de la Junta Directiva del Distrito.

Antes del 60.º día previo al Día de Elección, el Administrador General deberá entregar el aviso de la elección al funcionario electoral y al registrador de votantes del Condado de Travis en conformidad con la Sección 4.008 del Código Electoral.

El aviso de elección también puede ser proporcionado por cualquier otro medio de notificación autorizado por ley.

Sección 13: La elección se celebrará y realizará, y el dictamen de los resultados se dará a esta Junta Directiva en conformidad con el Código Electoral de Texas, modificado por las disposiciones correspondientes de los Capítulos 49 y 54 del Código de Agua de Texas.

Sección 14: el Administrador de Elecciones del Condado de Travis determinará la tarifa de pago de los jueces y funcionarios electorales.

Sección 15: Se autoriza e instruye al Presidente y al Secretario y al asesor legal del Distrito a tomar todas las medidas necesarias para implementar las disposiciones de esta orden.
