TO ALL THE REGISTERED VOTERS OF THE MANOR INDEPENDENT SCHOOL DISTRICT:

Notice is hereby given that an election shall be held on the 4th day of November, 2025, a uniform election date, in the Manor Independent School District (the "District") for the purpose of conducting a bond election (the "Election").

Por este medio, se notifica que se llevará a cabo una elección el día 4 de noviembre del 2025, una fecha uniforme de elección, en el Distrito Escolar Independiente de Manor (el "Distrito"), con el propósito de conducir una elección sobre bonos de obligación (la "Elección").

Bond Election – Official Propositions. The District will hold this Election for the purpose of determining whether the Board of Trustees of the District shall be authorized to issue bonds of the District in the amounts and for the purposes identified below, at which Election the following Propositions shall be submitted in accordance with law:

Proposition A

THIS IS A PROPERTY TAX INCREASE

"Shall the Board of Trustees of Manor Independent School District be authorized to issue and sell at any price or prices the bonds of the District in the principal amount not to exceed \$359,500,000.00 for the construction, renovation, acquisition, and equipment of school buildings in the District, the purchase of the necessary sites for school buildings, and the purchase of new school buses and other new vehicles to be used for student transportation, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates (fixed, floating, variable, or otherwise), not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the board of trustees of the district within the discretion of the board at the time of issuance; and shall the board of trustees be authorized to levy, impose and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the district sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the costs of any credit agreements executed in connection with the bonds?"

Proposition B

"Shall the Board of Trustees of Manor Independent School District be authorized to issue and sell at any price or prices the bonds of the District in the principal amount not to exceed \$8,500,000.00 for the acquisition of technology equipment, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates (fixed, floating, variable, or otherwise), not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the Board of Trustees of the District within the discretion of the Board at the time of issuance; and shall the Board of Trustees be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the costs of any credit agreements executed in connection with the bonds?"
