

**ORDER DECLARING ELECTION OF UNOPPOSED CANDIDATES  
AND CANCELING NOVEMBER 5, 2024 DIRECTOR ELECTION**

WHEREAS, the Board of Directors of Travis County Water Control & Improvement District No. 10 (“Board”) has called a director election for November 5, 2024 (“Election”); and

WHEREAS, the deadline to submit an application for a place on the ballot for the Election was August 19, 2024, and the deadline to file an application for write-in candidacy for the Election was August 23, 2024; and

WHEREAS, the Secretary of the Board is the authority responsible for having the official ballots prepared for the Election and, on the 26<sup>th</sup> day of August 2024, submitted to the Board a “Certification of Unopposed Status of Candidate for Place 1 for the November 5, 2024 Director Election,” attached as **Exhibit “A.”** a “Certification of Unopposed Status of Candidate for Place 3 for the November 5, 2024 Director Election,” attached as **Exhibit “B.”** a “Certification of Unopposed Status of Candidate for Place 4 for the November 5, 2024 Director Election,” attached as **Exhibit “C.”**; and

WHEREAS, under Section 2.053 of the Texas Election Code, if the Board receives a Certification of Unopposed Status, it may declare each unopposed candidate elected to office.

**NOW, THEREFORE,** the Board orders that:

1. The “Certification of Unopposed Status of Candidate for Place 1 for the November 5, 2024 Director Election”, signed on the 26<sup>th</sup> day of August 2024, and attached hereto as **Exhibit “A.”** is accepted.
2. The “Certification of Unopposed Status of Candidate for Place 3 for the November 5, 2024 Director Election”, signed on the 26<sup>th</sup> day of August 2024, and attached hereto as **Exhibit “B.”** is accepted.
3. The “Certification of Unopposed Status of Candidate for Place 4 for the November 5, 2024 Director Election”, signed on the 26<sup>th</sup> day of August 2024, and attached hereto as **Exhibit “C.”** is accepted.
4. David Fillpot is elected to office as Place 1 Director, Jon Luce is elected to office as Place 3 Director, and Emmet McCall is elected to office as Place 4 Director for Travis County Water Control & Improvement District No. 10, their terms will begin on November 5, 2024, and they will begin their duties as Director after executing a Statement of Elected Officer and taking the Oath of Office.
5. The Election is canceled.

- This Order will constitute a Certificate of Election, and the Secretary of the Board is directed to issue and deliver a copy to each candidate as required by Section 67.016 of the Election Code and to post a copy of this Order at the polling place on Election Day as required under Section 2.053 of the Election Code.

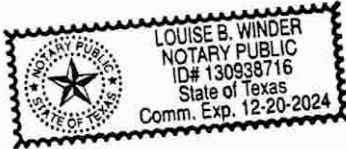
