Travis County Emergency Services District No. 9 (the "District") is holding elections on November 3, 2026, within the District and within the territory proposed to be annexed into the District to submit to qualified voters the question of such annexation. On behalf of the District and as required by Section 4.008 of the Texas Election Code, I have enclosed a copy of the resolution calling the above-described elections in both English and Spanish (the "Resolution Ordering Elections"), which serves as notice of said elections.

Section 4.008(a) of the Texas Election Code requires Travis County to post notice of the elections, including the location of each polling place, on Travis County's Internet website. Please note that the polling locations are not attached to the Resolution Ordering Elections as we have not received them from your office yet. We will submit a separate instruction letter, along with the Resolution Ordering Elections (with polling locations attached), the Notice of Elections, and affidavits of posting, with respect to the Section 4.008(a) posting requirements, upon receipt of Travis County's polling locations.

Please print and execute the acknowledgment below as evidence of the District's compliance with Section 4.008 of the Election Code and return the signed acknowledgement to us via email (stweet@lglawfirm.com) at your convenience for the District's records.

A RESOLUTION ORDERING ELECTIONS TO BE HELD RESPECTIVELY IN
TRAVIS COUNTY EMERGENCY SERVICES DISTRICT NO. 9 AND IN TERRITORY
PROPOSED TO BE ANNEXED THERETO, AND MAKING PROVISION FOR THE
CONDUCT OF THE ELECTIONS AND RESOLVING OTHER MATTERS INCIDENT
AND RELATED TO SUCH ELECTIONS

WHEREAS, Travis County Emergency Services District No. 9 (the “***District***”) is an emergency services district organized under Article III, Section 48-e, of the Texas Constitution, and operating pursuant to Chapter 775 of the Texas Health and Safety Code;

WHEREAS, Section 775.051 of the Texas Health and Safety Code provides that qualified voters who own taxable real property in a defined territory that is not included in a district may file a petition with the secretary of the board requesting the inclusion of the territory in the district;

WHEREAS, the Board of Commissioners (“***Commissioners***”) of the District received a petition requesting the annexation of certain territory, generally described as certain lots (and as applicable, tracts) fronting on Lake Austin between Tom Miller Dam and 2940 Oestrick Lane, into the District pursuant to Texas Health and Safety Code § 775.051(a) (the “***Petition***”);

WHEREAS, the Commissioners determined that the Petition was legally sufficient, having been signed by more than fifty (50) qualified voters who own taxable real property in the territory proposed to be annexed into the District;

WHEREAS, after providing due notice according to Texas Health and Safety Code § 775.051(b)-(d), the Commissioners held a public hearing on the Petition on July 22, 2026, at Westlake Hills Presbyterian Church, 7127 Bee Caves Road, Austin, Texas 78746; and at such public hearing, the Commissioners received public commentary on the proposed annexation;

WHEREAS, by separate resolution, subsequent to such public hearing, the Commissioners approved annexation of the property contemplated by the Petition, more specifically described in the attached **Exhibit A**, incorporated herein (the “***Territory***”);

WHEREAS, pursuant to Texas Health and Safety Code § 775.051(e), annexation of the Territory is final when approved by a majority of the voters at an election held within the District and by a majority of voters at a separate election held within the Territory; and

WHEREAS, the Commissioners desire to call elections to be held on November 3, 2026 within the District and within the Territory for the purpose of submitting propositions on the proposed annexation to the voters; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF TRAVIS COUNTY EMERGENCY SERVICES DISTRICT NO. 9 THAT:

Section 1: The matters and facts set out in the recitals of this Resolution are hereby found and declared to be true and complete.

Section 2: Special elections shall be held within the District and within the Territory on November 3, 2026, a uniform election date in the State of Texas, which date is seventy (70) or more days from the date of the adoption of this Resolution, between the hours of 7:00 a.m. and 7:00 p.m. at such polling places determined by Travis County, Texas (the “**County**”) and such polling places are hereby established and designated as set forth collectively on **Exhibit B** to this Resolution. **Exhibit B** shall be revised and finalized, if necessary, as directed by the County Elections Administrator. The County Elections Administrator is conducting the elections pursuant to an Election Agreement between the District and the County Elections Administrator as authorized under Section 31.092 of the Texas Election Code (the “**Election Agreement**”). The elections may be held as joint elections pursuant to Chapter 271 of the Texas Election Code and a joint election agreement to be entered into between the District and the other eligible participating entities located in the County which are holding an election on November 3, 2026. The County's election equipment, as applicable and appropriate, shall be used in the elections. At the elections, there shall be submitted the questions of (A) adding the Territory to the District, and (B) the Territory assuming its proportionate share of the outstanding debts and taxes of the District, if it is added to the District. The election judges and clerks shall be appointed in accordance with the Election Agreement and Texas Election Code, as amended.

Section 3: Voting in the elections for the propositions shall be by the use of electronic or paper ballots which shall show the propositions in both English and Spanish and which shall conform to the requirements of federal law, including the Help America Vote Act, and the Texas Election Code, as amended. The order of the propositions on the ballot shall be in accordance with the Texas Election Code. The ballots used in the election in the District and in the Territory shall contain the following:

The ballots for the elections shall provide for voting “for” or “against” the propositions. A vote “for” shall mean a vote in favor of the proposition, and a vote “against” shall mean a vote opposing the proposition.

Section 4: Oral assistance in Spanish shall be made available to all persons requiring such assistance. Any person requiring oral assistance in Spanish should contact the presiding judge or the early voting clerk.

Section 5: The early voting ballot board presiding judge and the alternate presiding judge shall be appointed in accordance with the Election Agreement and the Texas Election Code.

Early voting in the elections by personal appearance shall be conducted at the times, dates and polling places as determined by Travis County, and such polling places are hereby established and designated as set forth collectively in **Exhibit B** to this Resolution and this exhibit is incorporated by reference for all purposes. **Exhibit B** shall be revised and finalized, if necessary, as directed by the County Elections Administrator. Dyana Limon-Mercado is the Early Voting Clerk. Applications for ballots by mail for voters in Travis County should be sent to the Travis County Elections Division, P.O. Box 149325, Austin, Texas 78714. Additional contact information for the Early Voting Clerk is provided below for purposes of compliance with Section 83.010 of the Texas Election Code:

Section 6: In all respects, the elections shall be conducted in accordance with the Texas Election Code, Texas Health and Safety Code, and the Federal Help America Vote Act. Every polling place used in Travis County for this election will have at least one Direct Recording Electronic voting device available for Election Day voting and early voting. The County Clerk may use a central counting station as provided by Section 127.000 et seq. as amended, Texas Election Code. The central counting station Presiding Judge and the Alternate Presiding Judge shall be appointed in accordance with each Election Agreement.

Section 7: In accordance with Section 4.003(a)(1) of the Texas Election Code, a substantial copy of this Resolution (or such other appropriate form of notice consistent with applicable law), appearing in English and Spanish, shall serve as proper notice of said elections, and the President of the Board of Commissioners or other representatives of the District shall cause the notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date set for the elections, in a newspaper published in the District or, if none is published in the District, in a newspaper of general circulation in the District. In addition, in accordance with Section 4.003(a)(2) of the Texas Election Code, a substantial copy of this Resolution, appearing in English and Spanish, shall be posted, in accordance with the Texas Election Code not later than the 21st day before the elections.

Section 8: Immediately after the elections, the officers holding same shall make and deliver returns of the results thereof to the Secretary of the Board of Commissioners, who shall safely keep them and deliver same to the Commissioners, at which the Commissioners shall canvass the returns and declare the results of the elections pursuant to Section 67.003 of the Texas Election Code, as amended.

Section 9: Fire Chief David Wilson is authorized and directed to take any action necessary to carry out the provisions of this Resolution. Without limiting the generality of the foregoing, the Commissioners acknowledge that information required to complete the Exhibits to this Resolution may not be available when the election is ordered, and the Commissioners therefore authorize each of the foregoing or their designee to correct, modify, or change the Exhibits to the extent permitted by applicable law. Additionally, the Commissioners authorize this individual to make technical modifications to this Resolution that are necessary for compliance with applicable law or to carry out the intent of the Commissioners.

Section 10: It is hereby found that the meeting at which this Resolution has been considered and adopted was open to the public, as required by law, and that written notice of the time, place, and subject matter of said meeting, and of the proposed adoption of this Resolution, was given as required by Chapter 551 of the Texas Government Code. The Commissioners further ratify and confirm said written notice and the contents and posting thereof.

Section 11: Any notices authorized by this Resolution shall be modified as necessary and appropriate to take into account any future proclamations issued by the Governor impacting the elections.

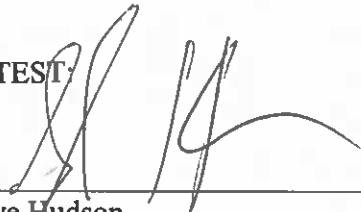

The Territory

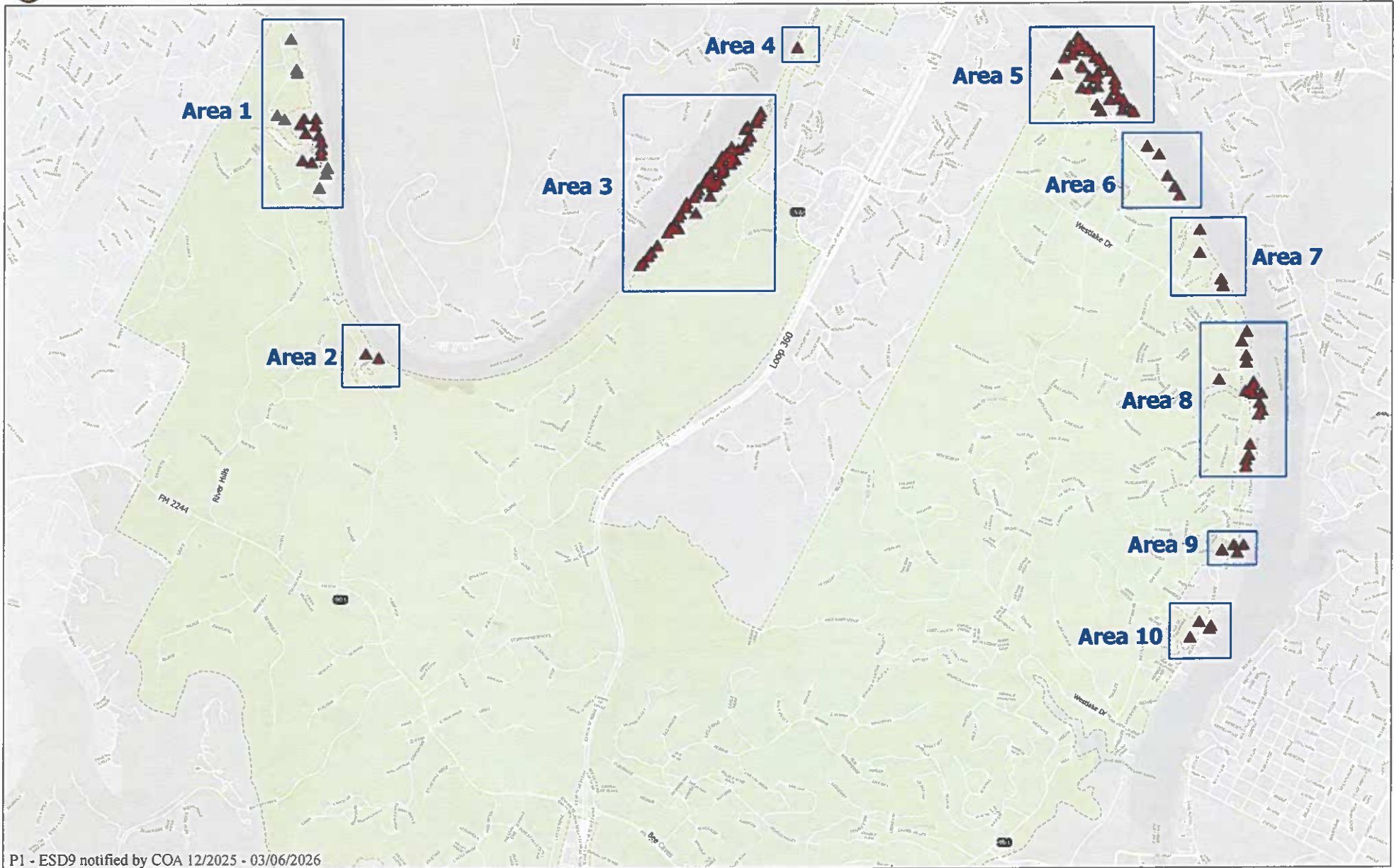


DISANNEXATION - All Areas

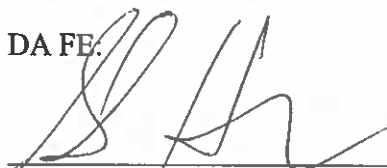

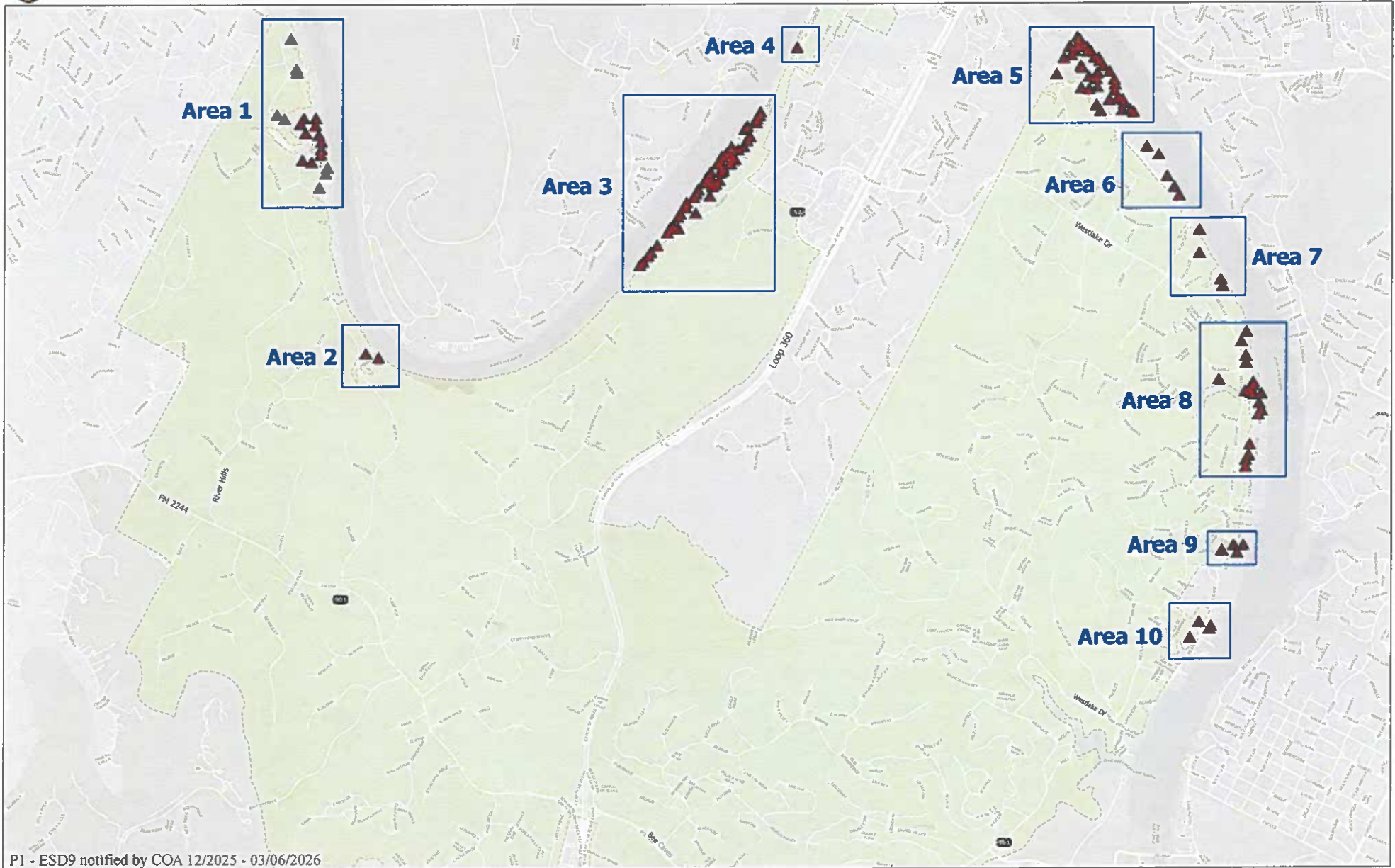
