ORDINANCE NO. 20220203-050

AN ORDINANCE AMENDING ORDINANCE NO. 20220118-002 ORDERING A SPECIAL MUNICIPAL ELECTION REGARDING MEASURES TO ELIMINATE LOW-LEVEL MARIJUANA ENFORCEMENT AND BAN NO-KNOCK WARRANTS TO REVISE SECTION 16-1-1 TO REFLECT THE CORRECT SECTION LETTERING AS SET FORTH IN THE CITIZEN-INITIATED ORDINANCE; TO SET THE HOURS OF VOTING ON ELECTION DAY AND ADD EXHIBIT A REGARDING EARLY VOTING DATES, TIMES, AND LOCATIONS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Ordinance No. 20220118-002 ordering a special municipal election regarding measures to eliminate low-level marijuana enforcement and ban no knock warrants is amended to correct lettering in Section 16-1-1 of the citizen-initiated ordinance so that it accurately reflects the petitioners' ordinance, as follows:

§ 16-1-1 ENDING CITATIONS AND ARRESTS FOR MISDEMEANOR POSSESSION OF MARIJUANA.

(A) Austin police officers shall not issue citations or make arrests for Class A or Class B misdemeanor possession of marijuana offenses, except in the limited circumstances described in §16-1-1(B).

(AB) The only circumstances in which Austin police officers are permitted to issue citations or make arrests for Class A or Class B misdemeanor possession of marijuana are when such citations or arrests are part of:

- (1) the investigation of a felony level narcotics case that has been designated as a high priority investigation by an Austin police commander, assistant chief of police, or chief of police; and/or
- (2) the investigation of a violent felony.

(BC) In every instance other than those described in §16-1-1(B), if an Austin police officer has probable cause to believe that a substance is marijuana, an officer may seize the marijuana. If the officer seizes the marijuana, they must write a detailed report and release the individual if possession of marijuana is the sole charge.

(€D) Austin police officers shall not issue any charge for possession of marijuana unless it meets one or both of the factors described in § 16-1-1(B).


PART 2. Ordinance No. 20220118-002 ordering a special municipal election regarding measures to eliminate low-level marijuana enforcement and ban no- knock warrants is further amended to provide that the hours of voting on election day will be between the hours of 7:00 a.m. and 7:00 p.m. and to add Exhibit A, attached herein, regarding the location of the main early voting polling place, the dates and hours for early voting, and the early voting clerk's official mailing address.

PART 3. The Council finds that the need to immediately begin required preparations for this election constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.



UNA ORDENANZA PARA ENMENDAR LA ORDENANZA NÚM. 20220118-002 QUE CONVOCA LA ELECCIÓN ESPECIAL MUNICIPAL SOBRE MEDIDAS PARA DESPENALIZAR LA MARIJUANA EN BAJO NIVEL Y PROHIBIR LAS ÓRDENES DE NO TOCAR PARA CORREGIR LAS LETRAS EN LA SECCIÓN 16-1-1 DE LA ORDENANZA INICIADA POR LOS CIUDADANOS PARA QUE PRECISAMENTE REPRESENTE LA ORDENANZA DE LOS PETICIONARIOS; PARA INDICAR LAS HORAS DE VOTACIÓN EL DÍA DE LA ELECCIÓN Y PARA AGREGAR EL ADJUNTO A SOBRE LAS FECHAS, HORAS, Y UBICACIONES DE LA VOTACIÓN ADELANTADA; Y PARA DECLARAR UNA EMERGENCIA.

ORDÉNESE POR EL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. La Ordenanza Núm. 20220118-002 que convoca la elección especial municipal sobre medidas para despenalizar la marihuana en bajo nivel y prohibir las ordenes de no tocar por la presente se enmienda para corregir las letras en la Sección 16-1-1 de la ordenanza iniciada por los ciudadanos para que precisamente represente la ordenanza de los peticionarios, como sigue:

§ 16-1-1 PONER FIN A LAS CITACIONES Y ARRESTOS POR DELITOS MENORES DE POSESIÓN DE MARIJUANA.

(A) Los oficiales de policía de Austin no emitirán citaciones ni harán arrestos por delitos menores de posesión de marihuana de Clase A o Clase B, excepto en las circunstancias limitadas descritas en §16-1-1 (B).

(AB) Las únicas circunstancias en las que a los oficiales de policía de Austin se les permite emitir citaciones o hacer arrestos por posesión de marihuana por delito menor de Clase A o Clase B son cuando tales citaciones o arrestos son parte de:

(1) la investigación de un caso de narcóticos a nivel de delito grave que ha sido designado como una investigación de alta prioridad por un comandante de policía de Austin, un jefe asistente de policía o un jefe de policía; y/o

(2) la investigación de un delito grave violento.

(BC) En todos los casos que no sean los descritos en §16-1-1 (B), si un oficial de policía de Austin tiene una causa probable para creer que una sustancia es marijuana, un oficial puede incautar la marijuana. Si el oficial incauta la marijuana, debe escribir un informe detallado y liberar al individuo si la posesión de marijuana es el único cargo.

(CD) Los oficiales de policía de Austin no emitirán ningún cargo por posesión de marijuana a menos que cumpla con uno o ambos de los factores descritos en § 16-1-1 (B).


PARTE 2. La Ordenanza Núm. 20220118-002 que convoca la elección especial municipal sobre medidas para despenalizar la marijuana en bajo nivel y prohibir las órdenes de no tocar además se enmienda para proporcionar las horas de votación el día de la elección que serán entre las horas de 7:00 a.m. y 7:00 p.m. y para agregar el Adjunto A, adjuntado a la presente, tocante la ubicación del sitio principal de la votación adelantada, las fechas y horas de la votación adelantada, y la dirección oficial postal del/la secretario/a de la votación adelanta.

PARTE 3. El Consejo determina que la necesidad de empezar inmediatamente los preparativos requeridos para esta elección constituye una emergencia. Por dicha emergencia, esta ordenanza tiene vigor inmediatamente al aprobarse para la conservación inmediata del orden público, la salud y seguridad.



ORDINANCE NO. 20220118-002

AN ORDINANCE ORDERING A SPECIAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF AUSTIN ON MAY 7, 2022, TO SUBMIT TO THE VOTERS A PROPOSED CITIZEN-INITIATED ORDINANCE, CERTIFIED SUFFICIENT ON JANUARY 10, 2022, REGARDING THE CREATION OF THE "AUSTIN FREEDOM ACT OF 2021" INCLUDING MEASURES TO ELIMINATE LOW-LEVEL MARIJUANA ENFORCEMENT AND BAN NO-KNOCK WARRANTS; AND AUTHORIZING THE CITY CLERK TO ENTER INTO JOINT ELECTION AGREEMENTS WITH OTHER LOCAL POLITICAL SUBDIVISIONS AS MAY BE NECESSARY FOR THE ORDERLY CONDUCT OF THE ELECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. A special municipal election shall be held in the City of Austin on May 7, 2022, to submit to the voters of the City a proposed citizen-initiated ordinance regarding the elimination of low-level marijuana offenses and banning the use of "no-knock" warrants by Austin police. The ballot shall be prepared to permit voting "Yes" or "No" on the Proposition:

Proposition A: Shall an initiative ordinance be approved to (1) eliminate enforcement of low-level marijuana offenses and (2) ban the use of "no knock" warrants by Austin police?

PART 2. If the proposition provided in Part 1, above, is approved by a majority of voters voting at the election, the City Code is amended as indicated below:

An ordinance creating the "Austin Freedom Act of 2021" including measures to eliminate low-level marijuana enforcement and ban no-knock warrants.

BE IT ORDAINED BY THE VOTERS OF THE CITY OF AUSTIN:

Part 1. Title 16 of the City Code is hereby created, to be titled "Austin Freedom Act of 2021."

Part 2. Title 16, Chapter 16-1 is hereby created to read: CHAPTER 16-1. ELIMINATION OF MARIJUANA ENFORCEMENT.

§ 16-1-1 ENDING CITATIONS AND ARRESTS FOR MISDEMEANOR POSSESSION OF MARIJUANA.

Austin police officers shall not issue citations or make arrests for Class A or Class B misdemeanor possession of marijuana offenses, except in the limited circumstances described in § 16-1-1(B).

- (A) The only circumstances in which Austin police officers are permitted to issue citations or make arrests for Class A or Class B misdemeanor possession of marijuana are when such citations or arrests are part of:
 - (1) the investigation of a felony level narcotics case that has been designated as a high priority investigation by an Austin police commander, assistant chief of police, or chief of police; and/or
 - (2) the investigation of a violent felony.
- (B) In every instance other than those described in § 16-1-1(B), if an Austin police officer has probable cause to believe that a substance is marijuana, an officer may seize the marijuana. If the officer seizes the marijuana, they must write a detailed report and release the individual if possession of marijuana is the sole charge.
- (C) Austin police officers shall not issue any charge for possession of marijuana unless it meets one or both of the factors described in § 16-1-1(B).

§ 16-1-2 CITATIONS FOR POSSESSION OF DRUG RESIDUE OR DRUG PARAPHERNALIA SHALL NOT BE ISSUED IN LIEU OF A POSSESSION OF MARIJUANA CHARGE.

- (A) A class C misdemeanor citation for possession of drug residue or drug paraphernalia shall not be issued in lieu of a possession of marijuana charge.

§ 16-1-3 PROHIBITION AGAINST USING CITY FUNDS OR PERSONNEL TO CONDUCT THC CONCENTRATION TESTING.

- (A) No City funds or personnel shall be used to request, conduct, or obtain tetrahydrocannabinol (THC) testing of any cannabis-related substance to determine whether the substance meets the legal definition of marijuana under state law, except in the limited circumstances of a police investigation pursuant to § 16-1-1(B).
- (B) This prohibition shall not limit the ability of Austin police to conduct toxicology testing to ensure public safety, nor shall it limit THC testing for the purpose of any violent felony charge.

Part 3. Title 16, Chapter 16-2 is hereby created to read: CHAPTER 16-2. BAN ON NO-KNOCK WARRANTS.

§ 16-2-1 “NO KNOCK” SEARCH WARRANTS SHALL NOT BE USED. No Austin police officer may request, execute, or participate in the execution of any search warrant that does not require the officer to knock and announce their presence and wait at least 15 seconds prior to execution.

§ 16-2-2 OFFICER DISCIPLINE. Any violation of this chapter may subject an Austin police officer to discipline as provided by the Texas Local Government Code, Chapter 143, or as provided in City policy.

PART 3. A direct electronic recording voting system, as the term is defined in Title 8 of the Texas Election Code, shall be used for early voting and for voting conducted on election day. The central counting station is established at the Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas.

PART 4. Notice of this election shall be posted and published in accordance with state law. The notice shall be posted, in both English and Spanish, in the office of the City Clerk and at the City Hall notice kiosk not later than the 21st day before election day. Notice of this election shall be published one time, in English and Spanish, not earlier than the 30th day before the date of the election or later than the 10th day before the date of the election, in a newspaper of general circulation in the City of Austin.


PART 5. In accordance with Chapter 271 of the Texas Election Code, the May 7, 2022 special municipal election may be held jointly with the various political subdivisions that share territory with the City of Austin and that are holding elections on that day. The City Clerk may enter and sign joint election agreements with other political subdivisions for this purpose, and their terms as stated in the agreements are hereby adopted.

PART 6. This ordinance takes effect on January 28, 2022.





UNA ORDENANZA PARA CONVOCAR UNA ELECCIÓN ESPECIAL MUNICIPAL EN LA CIUDAD DE AUSTIN EL 7 DE MAYO, 2022, PARA SOMETER A LOS VOTANTES UNA ORDENANZA INICIADA POR LA CIUDADANIA, CERTIFICADA POR SER SUFICIENTE EL 10 DE ENERO, 2022, PARA INSTITUIR LA “LEY DE LIBERTAD DE AUSTIN DE 2021” (“AUSTIN FREEDOM ACT OF 2021”) INCLUYENDO MEDIDAS PARA DESPENALIZAR LA MARIJUANA EN BAJO NIVEL Y PROHIBIR LAS ORDENES DE NO TOCAR; y PARA AUTORIZAR A LA SECRETARIA DE LA CIUDAD PARA QUE TRAMITE LOS CONVENIOS DE LA ELECCIÓN CONJUNTA CON OTRAS SUBDIVISIONES POLÍTICAS LOCALES, QUE SEAN NECESARIOS PARA LA ADMINISTRACIÓN ORDENADA DE LA ELECCIÓN

ORDÉNESE POR EL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. Una elección municipal especial será llevada a cabo en la Ciudad de Austin el 7 de mayo, 2022 para someter a los votantes de la Ciudad la ordenanza propuesta iniciada por los ciudadanos tocante la despenalización de delitos de marijuana en bajo nivel y prohibir las ordenes de “no tocar” por la policía de Austin. La boleta se preparará para permitir el voto de “Sí” o “No” sobre la proposición:

Proposición A: ¿Será aprobada la ordenanza por iniciativa para (1) despenalizar la marijuana en bajo nivel y (2) prohibir las ordenes de “no tocar” por la policía de Austin?

PARTE 2. Si la proposición indicada en la Parte 1, arriba, es aprobada por la mayoría de votantes que votan en la elección, el Código de la Ciudad será enmendado en conformidad con lo siguiente:

Una ordenanza que instituye la “Ley de Libertad de Austin de 2021” (“Austin Freedom Act of 2021”) incluyendo medidas para despenalizar la marijuana en bajo nivel y prohibir las ordenes de no tocar.

ORDÉNESE POR LOS VOTANTES DE LA CIUDAD DE AUSTIN:

Parte 1. Título 16 del Código de la Ciudad por la presente se instituye con el título de “Ley de Libertad de Austin de 2021” (“Austin Freedom Act of 2021”).

Parte 2. Título 16, Capítulo 16-1 por la presente se instituye, y dice: **CAPÍTULO 16-1. DESPENALIZACIÓN DE LA MARIJUANA.**

§ 16-1-1 PONER FIN A LAS CITACIONES Y ARRESTOS POR DELITOS MENORES DE POSESIÓN DE MARIJUANA.

§ 16-1-2 LAS CITACIONES POR POSESIÓN DE RESIDUOS DE DROGAS O PARAFERNALIA DE DROGAS NO SE EMITIRÁN EN LUGAR DE UN CARGO DE POSESIÓN DE MARIJUANA.

(A) No se emitirá una citación por delito menor de clase C por posesión de residuos de drogas o parafernalia de drogas en lugar de un cargo de posesión de marijuana.

§ 16-1-3 PROHIBICIÓN DE USAR FONDOS O PERSONAL DE LA CIUDAD PARA REALIZAR PRUEBAS DE CONCENTRACIÓN DE THC.

(A) No se utilizarán fondos o personal de la Ciudad para solicitar, realizar u obtener pruebas de tetrahidrocannabinol (THC) de cualquier sustancia relacionada con el cannabis para determinar si la sustancia cumple con la definición legal de marijuana bajo la ley estatal, excepto en las circunstancias limitadas de una investigación policial de conformidad con §16-1-1(B).

(B) Esta prohibición no limitará la capacidad de la policía de Austin para realizar pruebas toxicológicas para garantizar la seguridad pública, ni limitará las pruebas de THC con el propósito de cualquier cargo de delito grave violento.

Parte 3. Título 16, Capítulo 16-2 por la presente se instituye y dice: CAPÍTULO 16-2. PROHIBICIÓN DE ÓRDENES DE NO TOCAR.

§ 16-2-1 NO SE UTILIZARÁN ÓRDENES DE REGISTRO de "NO TOCAR". Ningún oficial de policía de Austin puede solicitar, ejecutar o participar en la ejecución de ninguna orden de registro que no requiera que el oficial toque y anuncie su presencia y espere al menos 15 segundos antes de la ejecución.

§ 16-2-2 DISCIPLINA DEL OFICIAL. Cualquier violación de este capítulo puede someter a un oficial de policía de Austin a disciplina según lo dispuesto por el Código de Gobierno Local de Texas, Capítulo 143, o según lo dispuesto en la política de la Ciudad.

PARTE 3. Un sistema electrónico indicador directo de votación que se define en el Título 8 del Código Electoral de Texas se usará para la votación adelantada y en la votación el día de la elección. La estación central para contar votos se ubicará en Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas.

PARTE 4. El aviso de esta elección será fijado y publicado de acuerdo con la ley estatal. El aviso será fijado, en ambos inglés y español en la oficina de la Secretaria de la Ciudad y en el kiosco de avisos del Edificio Municipal (City Hall), a no más tardar del 21vo día antes del día de la elección. El aviso de esta elección será publicado una vez, en inglés y en español, en fecha que no sea anterior del 30vo día antes de la fecha de la elección ni más tardar del 10mo día antes de la fecha de la elección, en un periódico de circulación general en la Ciudad de Austin.


PARTE 5. De acuerdo con el Capítulo 271 del Código Electoral de Texas, la elección municipal especial del 7 de mayo, 2022 se podrá llevar a cabo junto con varias subdivisiones políticas que comparten territorio con la Ciudad de Austin, y que estén efectuando elecciones en ese día. La Secretaria de la Ciudad puede tramitar y firmar convenios electorales con otras subdivisiones políticas para este propósito, y por la presente se aprueban los términos indicados en dichos convenios.

PARTE 6. Esta ordenanza tiene vigor el 28 de enero, 2022.


